

# TERMS AND CONDITIONS

By clicking "I AGREE" and/or using or accessing the Site, you thereby agree, (a) that you have received, read and understood these Terms and Conditions, and that these Terms and Conditions create a valid and binding agreement, enforceable against you in accordance with the terms hereof, (b) to be bound by these Terms and Conditions, any terms, conditions or other rules, regulations or policies of Trading Vitamins, as each may be amended or supplemented from time to time in our sole discretion without notice, and (c) that your use of the Site shall comply with all applicable federal, state and local laws, rules or regulations, and that you are solely responsible for your compliance with, familiarity with and understanding of any such laws, rules or regulations applicable to your use of the Site. If you do not agree with any portion of these Terms and Conditions, you are prohibited from using or accessing the Site.

Additionally, and without limiting the foregoing, by using or accessing the Site, you represent and warrant to us that you:

## Cancellation Policy

You can cancel your Trading Vitamins VIP monthly membership at any time. You can cancel by managing your membership in the member management dashboard directly through discord launchpass support or your cancellation portal. This will set your subscription to cancel by the end of the billing period. Not immediately.

## Refund Policy

We do not provide refunds upon completion, processing of the payment, access to the apps and recurring payments in accordance with the membership package selected. Our content is valuable, therefore by acquiring access to our content within the server you are receiving instant access to exclusive paid-for content which cannot be refunded.

If you do not wish to auto-renew your vip monthly membership, you must login to your account via our member management website [HERE](#) where you can cancel your membership renewal or change card details.

All subscription plans are auto-renewed and recharged on a recurring basis in relation to the membership subscription package chosen.

Trading Vitamins Inc holds no liabilities or grace-period for the customers responsibility in ensuring they understand the recurring billing period in relation to the plan they have accepted and paid for.

## Purchases and Refunds II

When purchasing a subscription, membership, or other periodic fee-based services on the Site, a valid credit card will be required for billing purposes. You hereby consent to, acknowledge, and allow Trading Vitamins Inc to store such payment information and agree to the following policies and procedures for payment of subscription, membership, or other periodic fees related to the Site. This means that access can be removed immediately without a refund. Since we have a clear and explicit no-refund policy in our Terms of Service that you have to agree to prior to completing the purchase of any of our Programs, Products, or Services, we do not tolerate or accept any type of chargeback threat or actual chargeback from your debit or credit card company. In the event that a chargeback is placed on a purchase or we receive a chargeback threat during or after your purchase, we reserve the right to report the incident to all credit reporting agencies or to any other entity for inclusion in any chargeback database. The information reported will include your name, email address, order date, order amount, TradingView username, Discord Username, customer communication, customer signature, receipt, billing address, and relevant metadata such as order id, user id. Payment method data will also be reported such as ID, Last 4 Card Number, Card Expired date, Card Type, and Card Issuer. Device location will be provided as well. Chargeback abusers wishing to be removed from the database shall make the payment for the amount of the chargeback.

In the event that a chargeback is placed on a purchase or we receive a chargeback threat during or after your purchase, we reserve the right to terminate your membership and remove access immediately.





## Access to our Products

Our products are completely digital and are accessed through Discord and Tradingview. In order to get access to any proprietary indicator or system, a Tradingview account username is needed. Once a purchase is made, the customer is fully responsible to contact us via email with the necessary details so that Trading Vitamins Inc can grant access. If we don't receive the necessary details we can't grant the customer access to our products. The customer is fully aware that it's their responsibility to provide us via email their Tradingview username. Once we have all information needed we will grant the customer access as soon as possible, it may take up to 48 hours. If the customer doesn't give us the necessary details such as Usernames and receipt/invoice/transactions id that can trace the transaction we at Trading Vitamins Inc will wait until we get the information from the customer hence the membership will be renewed automatically until the customer requests to cancel.

The access on Tradingview or Discord is not logged, hence Trading Vitamins Inc can't trace any access event. In the event that a chargeback is placed on a purchase or we receive a chargeback threat during or after your purchase, and the customer says that they don't have had access to our products, you agree that once you have provided us with your details, it is valid as a proof that you have had access. We do also take screenshots and store customer communication to ensure that we have the proof needed to ensure that we can prove that the customer has had access.

## Cookies

These websites may collect data about you, use cookies, embed additional third party tracking, and monitor your interaction with that embedded content. If you leave a comment on our site you may opt-in to saving your name, email address and website in cookies. These are for your convenience so that you do not have to fill in your details again when you leave another comment. These cookies will last for one year.

If you visit our login page, we will set a temporary cookie to determine if your browser accepts cookies. This cookie contains no personal data and is discarded when you close your browser.

When you log in, we will also set up several cookies to save your login information and your screen display choices. Login cookies last for two days, and screen options cookies last for a year. If you select "Remember Me", your login will persist for two weeks. If you log out of your account, the login cookies will be removed.

If you edit or publish an article, an additional cookie will be saved in your browser. This cookie includes no personal data and simply indicates the post ID of the article you just edited. It expires after 1 day.



## Ownership; Limited License
