

****Cartoon Money Printers LLC End-User License Agreement****

****Effective Date: April 1, 2024****

This End-User License Agreement ("EULA") is a legal agreement between you ("User" or "Licensee") and Cartoon Money Printers LLC ("Company," "we," "us," or "our") governing your use of the Cartoon Money Printers Discord server ("Server"), proprietary content, and services provided through our website, CartoonMoneyPrinters.com ("Website"). By accessing or using the Server and Website, you agree to be bound by the terms of this EULA.

****1. Grant of License****

Subject to the terms and conditions of this EULA, Cartoon Money Printers LLC grants you a limited, non-exclusive, non-transferable, revocable license to access and use the Server, Website, and proprietary content solely for your personal, non-commercial use.

****2. Restrictions on Use****

You agree not to:

- Copy, modify, distribute, or create derivative works of the Server, Website, or any proprietary content.
- Use the Server, Website, or proprietary content for any illegal or unauthorized purpose.
- Reverse engineer, decompile, or disassemble any software or content provided by Cartoon Money Printers LLC.
- Share your account credentials with any third party or allow any third party to access your account.

****3. Ownership****

All rights, title, and interest in and to the Server, Website, and proprietary content, including all intellectual property rights, are and shall remain the exclusive property of Cartoon Money Printers LLC or its licensors. This EULA does not grant you any ownership rights in the Server, Website, or proprietary content.

****4. Subscriptions and Fees****

Access to certain content and features of the Server and Website requires a paid subscription. By subscribing, you agree to pay the applicable subscription fees and any related charges. Subscription fees are non-refundable, except as provided in our Return and Refund Policy.

****5. Term and Termination****

This EULA is effective upon your acceptance and will remain in effect until terminated. Cartoon Money Printers LLC may terminate this EULA and your access to the Server and Website at any time, with or without cause, with immediate effect. Upon termination, you must cease all use of the Server, Website, and proprietary content.

****6. Disclaimer of Warranties****

The Server, Website, and all proprietary content are provided "as is" and "as available" without

warranties of any kind, either express or implied. Cartoon Money Printers LLC disclaims all warranties, including but not limited to implied warranties of merchantability, fitness for a particular purpose, and non-infringement.

****7. Limitation of Liability****

To the fullest extent permitted by law, Cartoon Money Printers LLC shall not be liable for any indirect, incidental, special, consequential, or punitive damages, or any loss of profits or revenues, whether incurred directly or indirectly, or any loss of data, use, goodwill, or other intangible losses, resulting from (i) your use or inability to use the Server or Website; (ii) any unauthorized access to or use of our servers and/or any personal information stored therein; and (iii) any other matters relating to the Server or Website.

You agree to indemnify, defend, and hold harmless Cartoon Money Printers LLC, its affiliates, and their respective officers, directors, employees, agents, licensors, and suppliers from and against all claims, losses, expenses, damages, and costs, including reasonable attorneys' fees, arising from your use of the Server, Website, or proprietary content, or any violation of this EULA.

This EULA shall be governed by and construed in accordance with the laws of The United States of America, without regard to its conflict of law principles.

****10. Changes to This EULA****

Cartoon Money Printers LLC reserves the right to modify this EULA at any time. Any changes will be effective immediately upon posting the revised EULA in the Server and on our Website. Your continued use of the Server and Website following the posting of changes will constitute your acceptance of such changes.
