

# Privacy Policy for The Dojo Discord Server

Welcome to The Dojo Discord Server! Your privacy is important to us. This Privacy Policy explains how The Dojo collects, uses, and protects your information when you access and use our Discord server. By joining and using The Dojo Discord Server, you agree to the terms outlined in this Privacy Policy.

## 1. Information We Collect

When you interact with The Dojo Discord Server, we may collect certain information. This primarily includes information that Discord itself collects as part of its platform, as well as information you directly provide to us or that is generated through your activity within our server.

**a. Information Collected by Discord (Platform Data):** As a user of the Discord platform, your data is subject to Discord's own Privacy Policy (available at [discord.com/privacy](https://discord.com/privacy)). This includes, but is not limited to:

- Your Discord User ID and Username
- Your IP address and device information
- Information about your usage of Discord (e.g., servers joined, channels visited, messages sent, voice activity)
- Any information you make public on your Discord profile.

## **b. Information You Directly Provide to Us:**

- **Membership Information:** When you sign up for a paid membership, we may collect information necessary for processing payments and managing your access, such as your payment details (handled by a third-party payment processor, not stored directly by The Dojo unless explicitly stated and necessary) and associated contact information.
- **Communications:** Any information you provide when you communicate with us directly, such as support inquiries, feedback, or participation in surveys.
- **Content You Share:** Messages, images, files, and other content you post or share within The Dojo Discord Server's channels, including public and private channels.

## **c. Information Generated Through Your Activity on The Dojo Discord Server:**

- **Interaction Data:** Records of your interactions within the server, such as messages sent, commands used (if applicable), and participation in events.
- **Server-Specific Data:** Information related to your roles, permissions, and activities specifically within The Dojo Discord Server.

## 2. How We Use Your Information

The information we collect is used for the following purposes:

- **To Provide and Maintain The Dojo Discord Server:** To grant you access to the server, manage your membership, provide the services and content offered, and ensure the server functions correctly.
- **To Enforce Our Terms of Service:** To monitor for and address violations of The Dojo's Terms of Service and Community Guidelines, including disrespectful behavior, content leaking, or unauthorized advertising, which may lead to suspension or termination of membership without refund.
- **To Improve and Customize Your Experience:** To understand how users interact with the server, gather feedback, and develop new features or content that enhance the user experience.
- **For Communication:** To send you important announcements, updates, or information related to your membership or the server.
- **For Promotional and Training Purposes:** As stated in our Terms of Service, we reserve the right to use content and/or media from the server for promotional or training purposes, including on The Dojo's and its subsidiaries' social media platforms. This may include screenshots of discussions, public messages (anonymized where appropriate to protect individual identities), or general server activity, provided it adheres to Discord's terms and our commitment to user privacy.
- **To Protect Our Rights and Interests:** To prevent fraud, troubleshoot technical issues, and protect the security and integrity of The Dojo and its members.
- **To Comply with Legal Obligations:** To meet any applicable legal or regulatory requirements.

## 3. Sharing Your Information

We do not sell your personal information. We may share your information in the following limited circumstances:

- **With Third-Party Service Providers:** We may use third-party services (e.g., payment processors, analytics tools) that require access to certain information to perform their services for us. These providers are obligated to protect your information and use it only for the purposes for which it was disclosed.
- **For Legal Reasons:** We may disclose your information if required to do so by law, in response to a court order, subpoena, or other legal process, or if we believe it's necessary to protect the rights, property, or safety of The Dojo, our members, or others.
- **In Case of Business Transfer:** If The Dojo undergoes a merger, acquisition, or sale of all or a portion of its assets, your information may be transferred as part of that transaction. We will notify you of any such change.
- **With Your Consent:** We may share your information with third parties when we have your explicit consent to do so.

## 4. Data Retention

We retain your information only for as long as necessary to fulfill the purposes outlined in this Privacy Policy, unless a longer retention period is required or permitted by law. This means we

will keep your membership information for the duration of your active membership and for a reasonable period thereafter for administrative and legal purposes. Content you post in the server will remain unless removed by you or a staff member.

## 5. Your Rights and Choices

Depending on your location and applicable privacy laws, you may have the following rights regarding your personal information:

- **Access:** Request a copy of the personal information we hold about you.
- **Rectification:** Request that we correct any inaccurate or incomplete information.
- **Erasure (Right to Be Forgotten):** Request the deletion of your personal information, subject to certain exceptions (e.g., legal obligations).
- **Restriction of Processing:** Request that we limit the way we use your personal information.
- **Data Portability:** Request to receive your personal information in a structured, commonly used, and machine-readable format.
- **Object to Processing:** Object to our processing of your personal information in certain circumstances.
- **Withdraw Consent:** Where we rely on your consent to process your information, you have the right to withdraw that consent at any time.

The Dojo Discord Server is not intended for individuals under the age of 13. We do not knowingly collect personal information from children under 13. If we become aware that we have inadvertently collected personal information from a child under 13, we will take steps to delete such information as quickly as possible.

## 8. Changes to This Privacy Policy

We may update this Privacy Policy from time to time to reflect changes in our practices or for other operational, legal, or regulatory reasons. We will notify you of any material changes by posting the updated Privacy Policy on the server or through other appropriate communication channels. Your continued use of The Dojo Discord Server after any changes indicates your acceptance of the revised Privacy Policy.
