

End-User License Agreement (EULA) for The Dojo Discord Server

IMPORTANT: PLEASE READ THIS END-USER LICENSE AGREEMENT CAREFULLY. BY ACCESSING, JOINING, OR USING THE DOJO DISCORD SERVER, YOU AGREE TO BE BOUND BY THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THESE TERMS, DO NOT ACCESS OR USE THE DOJO DISCORD SERVER.

This End-User License Agreement ("EULA" or "Agreement") is a legal agreement between you, the end-user ("User" or "You"), and The Dojo ("The Dojo," "We," "Us," or "Our") concerning your access to and use of The Dojo Discord Server and all associated content, features, and services provided therein (collectively, the "Server").

This EULA supplements, and should be read in conjunction with, The Dojo's Terms of Service and Privacy Policy.

1. Grant of License

Subject to your compliance with the terms and conditions of this EULA, our Terms of Service, and all applicable Discord policies, The Dojo grants you a limited, non-exclusive, non-transferable, revocable license to:

a. Access and use The Dojo Discord Server for your personal, non-commercial use for the duration of your active membership. b. View, read, and interact with the content, discussions, and resources made available within the Server.

2. License Restrictions

You agree not to, and will not permit others to:

a. **Modify, Adapt, or Create Derivative Works:** Modify, adapt, translate, reverse engineer, decompile, disassemble, or create derivative works based on The Dojo Discord Server or its content. b. **Unauthorized Distribution/Leakage:** Distribute, sell, rent, lease, sublicense, transfer, or otherwise make available any content, deals, or proprietary information shared within The Dojo Discord Server to any third party, group, or platform outside of the Server, as prohibited by our Terms of Service. c. **Commercial Use:** Use the Server or any of its content for any commercial purpose, including but not limited to self-advertising, promoting other groups, or engaging in any business activity without the express prior written consent of The Dojo. d. **Circumvention:** Bypass, disable, or otherwise interfere with any security-related features of the Server or Discord platform. e. **Data Mining/Scraping:** Use any robot, spider, site search/retrieval application, or other manual or automatic device or process to retrieve, index, "data mine," or in any way reproduce or circumvent the navigational structure or presentation of the Server or its contents. f. **Misuse:** Use the Server in any manner that is unlawful, harmful,

However, by posting or submitting content, you grant The Dojo a worldwide, non-exclusive, royalty-free, perpetual, irrevocable, and sublicensable license to use, reproduce, modify, adapt, publish, translate, create derivative works from, distribute, perform, and display such content for promotional, training, or operational purposes, as outlined in our Terms of Service.
