INTRODUCTION

this end user license agreement (“eula”) is a legal agreement between you and bookclub. bookclub is a south carolina-based prop-trading mentorship community that provides paid access to digital courses, downloadable materials, a private discord community, and proprietary coaching resources. by accessing or using the bookclub platform (through our website, app, or any other portal), you agree to be bound by the terms of this eula. all bookclub content is digital and is licensed to you for your personal use only – it is not sold to you. if you do not agree with these terms, you should not use bookclub.

LICENSE GRANT

bookclub grants you a limited, personal license to access and use the content and services we provide. this license is non-transferable and non-sublicensable, meaning you cannot give your account or access rights to anyone else. the content is for your individual, non-commercial use only. except for this license, you have no other rights to the content. bookclub retains the right to revoke this license at any time if you violate this eula.

RESTRICTIONS

to protect our intellectual property and the integrity of the community, bookclub imposes certain usage restrictions. you may not share your account or login credentials with anyone. your subscription and access are personal to you. you also may not copy, record, reproduce, distribute, or publicly display any bookclub content or materials without our permission. modifying or creating any derivative works based on bookclub content is strictly prohibited.

furthermore, you are not allowed to reverse engineer, decompile, or attempt to extract the source code or underlying ideas of any part of bookclub’s platform. you may not use any bookclub content to train artificial intelligence models or to develop competing products or services. any commercial use or resale of bookclub’s courses, materials, or resources is strictly forbidden.

OWNERSHIP

all rights, titles, and interests in and to bookclub (including all content, materials, software, logos, and trademarks) are owned by bookclub or its licensors. nothing in this agreement transfers any intellectual property ownership to you. the content is licensed, not sold, and you have no ownership rights in any of the digital materials or resources provided. all trademarks, logos, and service marks used in bookclub remain the property of their respective owners.

ACCOUNT SECURITY

you are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account. if you suspect any unauthorized use of your account or a security breach, you must notify bookclub immediately at support@kj.ventures. we reserve the right to suspend or terminate your access if we believe your account has been shared or compromised, to protect both you and our platform.

TERMINATION

bookclub may suspend or terminate your access to the platform at any time without notice if you violate any provision of this eula. if your account is terminated due to a breach of this agreement, you will not be entitled to any refund of fees paid. upon termination, your license to use bookclub content will immediately end, and you must stop accessing or using any bookclub materials. termination of your access or account does not waive or affect any rights or remedies that bookclub may have under this agreement or at law.

NO WARRANTIES

bookclub provides all content, materials, and services on an “as is” and “as available” basis. we make no warranties or guarantees of any kind about the accuracy, completeness, or effectiveness of the content. to the fullest extent allowed by law, bookclub disclaims all implied warranties, including any warranties of merchantability, fitness for a particular purpose, and non-infringement. using bookclub is at your own risk, and we do not promise any specific results or outcomes from the educational content.

LIMITATION OF LIABILITY

to the extent permitted by law, bookclub will not be liable to you for any indirect, consequential, incidental, or special damages. this means we are not responsible for losses like lost profits, lost data, or business interruptions. in any event, bookclub’s total liability for all claims related to your use of the platform or this agreement will be capped at the total amount you have paid to bookclub in the last 12 months.

GOVERNING LAW

this eula and any dispute arising from it or from your use of bookclub will be governed by the laws of south carolina, without regard to conflict of law principles. you agree that any disputes or claims will be resolved through binding arbitration on an individual basis. by agreeing to arbitration, both you and bookclub waive the right to a trial in court or to participate in a class action. you may only bring claims on your own behalf, and not as a plaintiff or class member in any class or representative action.

bookclub may update or revise this eula at any time. if we make material changes, we will notify you, for example through an email or a notice on our platform. the latest version of the eula will

always be available through bookclub. by continuing to use bookclub after changes to this agreement are posted, you agree to the updated terms.
