

END USER LICENSE AGREEMENT (EULA)

BFX LLC (Betflix)

Effective Date: August 20, 2025

This End User License Agreement (“Agreement” or “EULA”) is a binding legal contract between you (“User” or “You”) and BFX LLC, operating under the brand name Betflix (“Betflix,” “we,” “us,” or “our”). This Agreement governs your access to and use of Betflix digital products, services, content, and community features delivered through Whop, Discord, and associated platforms.

By purchasing, accessing, or using Betflix services, you agree to the terms of this EULA. If you do not agree, you must not use Betflix services.

1. License Grant

BFX LLC grants you a limited, non-exclusive, non-transferable, revocable license to access and use Betflix content strictly for personal, non-commercial, entertainment-only purposes.

You may not:

- Share, resell, or redistribute Betflix content outside approved platforms;
- Reverse-engineer, copy, or exploit Betflix models, methods, or tools;
- Allow others to access paid content using your account credentials.

Violation may result in immediate termination of access without refund, and BFX LLC reserves all legal rights to enforce its intellectual property.

2. Eligibility

You must be at least twenty-one (21) years old, or the age of majority in your jurisdiction (whichever is higher), to access Betflix services. By using our services, you represent and warrant that you meet this requirement.

Betflix may immediately revoke access without refund if this representation is false.

3. Intellectual Property

All Betflix content, including but not limited to:

- **Digital slips, screenshots, models, strategies, graphics, and software tools;**
- **Branding, logos, trademarks, and trade dress;**
- **Server structures, channel organization, and proprietary methods,**

is the exclusive property of BFX LLC. You receive no ownership rights. Unauthorized use, copying, or redistribution is strictly prohibited.

4. User Conduct

You agree to comply with all Betflix community rules, Whop's Terms of Service, and Discord's platform terms.

Prohibited conduct includes:

- **Sharing or misrepresenting Betflix content;**
- **Harassment, abusive language, or disruptive activity in the community;**
- **Using Betflix content as financial, gambling, or investment advice.**

Betflix may suspend or terminate access at its sole discretion for violations.

5. Payment & Access

- **All payments are processed exclusively through Whop.**
- **Access to Betflix services is contingent upon successful payment.**

- Users are solely responsible for managing their subscriptions through Whop.
 - Betflix cannot cancel, pause, or manage subscriptions for you.
 - Refunds are governed by the Betflix Refund Policy, which forms part of this Agreement.
 - Whop's Terms of Service and Privacy Policy also apply.

6. Privacy & Data

By using Betflix services, you consent to the collection and limited use of personal data required to operate subscriptions and access systems.

Data collected may include your Whop account details, Discord ID, and payment status.

- BFX LLC does not sell your personal data to third parties.
- Discord and Whop maintain separate privacy practices outside of BFX LLC's control.

By continuing to use Betflix, you also agree to Whop's and Discord's independent privacy policies.

7. Termination of Access

Betflix may suspend or permanently revoke your license without refund if you:

- Violate this EULA, community rules, or applicable laws;
- Engage in fraud, harassment, or unauthorized content distribution;
- File a chargeback or unauthorized payment dispute.

Chargebacks may result in permanent forfeiture of all access, past and future.

8. Entertainment & Disclaimer

Betflix content is provided strictly for entertainment purposes only.

- Betflix does not provide gambling, financial, or investment advice.
 - Betflix is not a sportsbook, casino, financial institution, or investment advisor.
 - No outcome, result, or performance is guaranteed.
 - Past performance does not guarantee future results.
 - You use all Betflix content at your own risk.

9. Limitation of Liability

To the maximum extent permitted by law:

- BFX LLC shall not be liable for any indirect, incidental, special, or consequential damages, including lost profits, lost opportunities, or data loss.

In no event shall BFX LLC's total liability to you exceed the greater of:

- The total fees you paid to BFX LLC in the 30 days immediately preceding the claim, or
- One hundred dollars (\$100 USD).

Nothing herein limits liability for fraud, willful misconduct, or any matter that cannot be excluded under applicable law.

10. Arbitration & Dispute Resolution

All disputes shall be resolved by binding arbitration in Maricopa County, Arizona, administered by the American Arbitration Association (AAA) under its Consumer Arbitration Rules.

- Users waive the right to a jury trial or class action.
 - Each party shall bear its own costs and attorneys' fees unless otherwise required by law.
 - If arbitration is deemed unenforceable, disputes must be litigated exclusively in the courts of Maricopa County, Arizona.

11. Governing Law

This Agreement is governed by the laws of the State of Arizona, without regard to conflict-of-law principles.

12. Severability

If any provision of this Agreement is held invalid or unenforceable, the remainder shall remain in full force. The invalid portion shall be modified to the minimum extent necessary to reflect the parties' original intent.

13. Updates to Agreement

Betflix may update this EULA at any time by posting revisions with a new effective date. Continued use of Betflix services after updates constitutes acceptance of the revised terms.

14. Entire Agreement

This EULA, together with the Betflix Refund Policy, Whop's Terms of Service, Whop's Privacy Policy, and any official policies or notices published within the official Betflix Discord server, constitutes the entire agreement between you and BFX LLC.

No oral or written statements outside this Agreement shall modify or supplement it.

By accessing Betflix content, you confirm you have read, understood, and agreed to this EULA.
