Before research delivery

In exceptional cases, an issue identified very early may mean I cannot provide useful work. If that happens, I'll explain the issue and arrange a refund.

When preferences conflict, the research can still help by showing the closest options and the compromises involved. A difficult brief does not, by itself, qualify for a refund.

After research delivery

Once I deliver researched recommendations or supported feasibility findings, a preference for a different outcome does not qualify for a refund. Those findings may include an explanation of why no place meets every requirement. Intake answers and brief confirmation do not count as research delivery.

If a recommendation does not feel right, tell me what you would like to reconsider. Your included round of adjustments remains available within the agreed brief. I'll correct research errors or missed requirements you had disclosed separately from that round.

Problems with the service

If you believe I have not provided the agreed work, contact me with the details so I can review it and resolve the issue. The conditions above do not remove remedies for work I fail to provide, applicable consumer rights, or payment-provider obligations.

Statutory cancellation rights

Where EU or UK distance-contract cancellation rights apply, you can cancel within 14 days after the contract is made, without giving a reason. Send a clear cancellation statement through Whop, email, or post using the contact details above before that period ends. You may use the wording below, but it is optional.

For a valid statutory cancellation, I will arrange reimbursement without undue delay, within 14 days of being informed. Refunds use the original payment method unless we agree otherwise, without a refund fee.

If you expressly request work during that period and the required information has been provided, you may owe a proportionate amount for service supplied before cancellation. I will explain the calculation. Without the required request or information, that deduction does not apply.

The right ends early only after full performance with the consent and acknowledgment required by law. The first report alone is not full performance when included work remains owed. Approving the brief does not itself waive cancellation rights. Any longer period or other protection required by applicable law takes precedence.
