

END USER LICENSE AGREEMENT

1. Agreement to Terms

2. License Grant

This license does not include any right to sublicense, resell, redistribute, or share access to the Services with any third party.

3. Restrictions

You agree that you will NOT:

- Use any automated tools, bots, or scrapers to extract data or content from our platforms without express written permission.
