

SpicerVisions — End User License Agreement (EULA)

This End User License Agreement (“EULA”) governs your use of SpicerVisions **licensed digital materials** (the “Licensed Materials”), which may include Notion templates, dashboards, databases, PDFs, guides, workbooks, scripts, creative assets, downloadable files, and pre-recorded videos.

This EULA applies only to Licensed Materials. Any other products or services (including coaching, subscriptions, events, or physical goods) are governed by the **SpicerVisions Terms of Service** and any **Product-Specific Terms** shown on the relevant product page or checkout.

1) License Grant (Personal Use; One Seat)

Subject to your compliance with this EULA, SpicerVisions grants you a **personal, non-exclusive, non-transferable, revocable license** to access and use the Licensed Materials for your **own personal use**.

“Personal use” means one individual (“one seat”) using the Licensed Materials for their own projects and workflow. If you want team, classroom, organization, or multi-user use, you must obtain a separate license if offered.

If a product listing explicitly allows a different use (e.g., commercial use, multi-seat, team license), that written listing controls for that specific Licensed Material.

Product-Specific Terms (Order of Precedence)

Some Licensed Materials may have additional license rules shown on the product page or inside the access/download instructions (“Product-Specific Terms”). **If Product-Specific Terms conflict with this EULA, the Product-Specific Terms control for that specific Licensed Material.**

2) No Transfer, No Sharing, No Resale

You may **not** (and may not allow others to):

- Copy, reproduce, redistribute, publish, upload, sell, resell, rent, lease, sublicense, or share the Licensed Materials (or any portion)

- Share access via public links, shared drives, “Notion sharing,” teamspaces, workspace invites, duplicate links, or password sharing
- Create or distribute derivative templates that are substantially similar to the Licensed Materials or that replicate their core structure/content for others
- Remove copyright notices, watermarks, branding, access controls, or attribution included in the Licensed Materials

3) Permitted Customization

You may:

- Duplicate templates into your own workspace(s) for personal use
- Customize for your own workflow (edit fields, colors, layouts, pages)
- Export personal copies for your own use (as allowed by the platform/tools you use)

4) Third-Party Platforms and Tools

Some Licensed Materials are used inside third-party platforms (e.g., Notion). Your use of those platforms is governed by their terms. SpicerVisions is not responsible for third-party outages, feature changes, account limitations, or platform policy changes.

5) Third-Party Content and Links

Some Licensed Materials may include **links** to third-party resources. Third-party content is owned by its respective creators. We do not host or control third-party materials and do not guarantee availability. You are responsible for complying with third-party terms and licenses.

6) Access, Updates, and Changes

We may update or improve Licensed Materials (including layouts, instructions, and files). Updates are provided at our discretion unless a product listing explicitly promises updates.

If access is provided through a subscription, continued access generally depends on an active subscription and Whop’s access controls.

7) Termination; Remedies

This license remains in effect unless terminated. We may terminate or suspend your license immediately if you violate this EULA (including sharing/redistribution or bypassing access controls). Upon termination, you must stop using the Licensed Materials and delete/destroy copies in your control where reasonably possible.

Unauthorized sharing can cause irreparable harm; we may seek legal remedies available under applicable law.

8) Eligibility and Minors

You must meet Whop's minimum age requirements. The Licensed Materials are **not intended for children under 13**, and we do not knowingly license to children under 13.

If you are **13–17** (or under the age of majority where you live), you may only use Licensed Materials with parent/guardian permission and supervision, and your parent/guardian agrees to this EULA on your behalf.

9) No Guarantees (Educational/Productivity Use)

Licensed Materials are provided as educational/productivity tools. **We do not guarantee** any outcomes, earnings, productivity gains, or results.

10) Disclaimer of Warranties (“As-Is”)

To the maximum extent permitted by law, the Licensed Materials are provided **“as is”** and **“as available,”** without warranties of any kind (express or implied), including merchantability, fitness for a particular purpose, and non-infringement.

11) Limitation of Liability
