

Terms of Service & End User License Agreement

Traders Launchpad — Last updated: July 6, 2026

These Terms of Service and End User License Agreement ("Agreement") govern your access to and use of content, communities, courses, signals, tools, and materials (collectively, the "Content") provided by Traders Launchpad ("we," "us," or "our") through the Whop platform. By purchasing a membership or otherwise accessing the Content, you ("Member" or "you") agree to be bound by this Agreement.

1. License Grant

Subject to your compliance with this Agreement and continued active membership, we grant you a limited, non-exclusive, non-transferable, revocable license to access and use the Content solely for your own personal, non-commercial use.

2. Prohibited Sharing & Redistribution

You may **not**, under any circumstances:

- Share, forward, repost, mirror, rebroadcast, or otherwise redistribute any Content — including but not limited to courses, lessons, trade signals, chat messages, livestreams, recordings, PDFs, or screenshots — to any person who is not an active, paying Member;
- Upload, post, or reproduce any Content on any external website, social media platform, file-sharing service, Discord server, Telegram channel, or other third-party service without our prior written consent;
- Sell, rent, lease, sublicense, or otherwise commercially exploit the Content;
- Create derivative works based on the Content and distribute them to non-Members;
- Use screen recording, screenshotting, or capture tools to reproduce Content for distribution outside your own personal reference.

3. Account & Access Sharing

Your membership and login credentials are personal to you and may not be shared, sold, leased, or transferred to any other individual. Each Member must maintain their own individual, unique account. We reserve the right to monitor for simultaneous or suspicious multi-user access and to suspend or terminate accounts showing evidence of shared access.

4. Enforcement & Termination

Violation of Sections 2 or 3 constitutes a material breach of this Agreement. We reserve the right, in our sole discretion and without refund, to:

- Immediately suspend or terminate your membership and access to all Content;
- Pursue civil remedies for damages caused by unauthorized distribution, including lost revenue and legal fees;
- Issue takedown requests to any platform hosting redistributed Content;
- Report copyright or intellectual property infringement to the relevant platform or authority.

5. Intellectual Property

All Content is owned by Traders Launchpad or its licensors and is protected by copyright, trademark, and other intellectual property laws. No ownership rights are transferred to you under this Agreement — only the limited

license described in Section 1.

6. No Warranty / Educational Purposes Only

The Content is provided for educational and informational purposes only and does not constitute financial, investment, legal, or tax advice. Trading involves substantial risk of loss and is not suitable for all individuals. Past performance is not indicative of future results. You are solely responsible for your own trading and financial decisions.

7. Refunds & Cancellations

Membership fees are billed according to the plan selected at checkout. Cancellations stop future renewals but do not entitle you to a refund for the current billing period unless otherwise required by law or explicitly stated in our Refund Policy.

8. Changes to This Agreement

We may update this Agreement from time to time. Continued use of the Content after changes are posted constitutes acceptance of the revised terms.
