

# Privacy Policy

This Privacy Policy describes how Global Gains Trading (also operating as “Glo Trades,” “Samu Trades,” “Funded University,” “Global Gains,” and related entities) (“we,” “us,” “our”) collects, uses, and protects your personal information when you access our Whop storefront, Discord community, website, courses, and related services (“Services”).

By using our Services, you agree to this Privacy Policy. If you do not agree, please discontinue use immediately.

## 1. Information We Collect

We collect the following types of information to operate effectively and deliver high-quality experiences:

### A. Information You Provide Directly

- Personal details: Name, email address, username, and payment information when you sign up or purchase from us.
- Account data: Login details, profile information, preferences, and communications sent through our Discord or website.
- Support messages: Information you provide when contacting us via email, Discord, or other support channels.

### B. Information Automatically Collected

When you access our website, Whop storefront, or Discord integrations, we may automatically collect:

- Device information (IP address, browser type, operating system, referral URLs)
- Usage data (pages visited, time spent, actions taken)
- Cookies and tracking tools to enhance functionality and security

## 2. How We Use Your Information

We use the information we collect to:

- Process purchases, subscriptions, and account registrations
- Provide access to educational content, mentorship programs, and Discord community features
- Send service updates, newsletters, and important notices
- Improve, personalize, and optimize user experience
- Protect against fraudulent, unauthorized, or illegal activity
- Comply with legal obligations

We do not sell, rent, or trade your personal data under any circumstances.

## 3. Payment Information

All payments are securely processed through Whop's third-party payment processors (such as Stripe or PayPal).

We do not store or access your full credit card information. Payment data is handled under PCI-DSS standards by those processors.

## 4. Data Sharing & Disclosure

We only share your information in the following limited situations:

- Service Providers: With trusted third parties that help us operate (e.g., payment processors, analytics tools, CRM systems) under strict confidentiality agreements.
- Legal Compliance: When required by law, subpoena, or court order.

- **Business Transfers:** In the event of a merger, acquisition, or asset sale, your data may be transferred under equivalent protection terms.

We never share or sell your personal information for marketing purposes.

## **5. Cookies & Tracking**

Our website and Whop storefront may use cookies, analytics tools (like Google Analytics), or similar tracking technologies to:

- Measure traffic and performance
- Remember login sessions and preferences
- Detect security risks or suspicious activity

You can adjust or disable cookies through your browser settings, though this may affect functionality.

## **6. Data Retention**

We retain personal data only as long as necessary to:

- Fulfill your purchases and account access
- Comply with legal obligations
- Resolve disputes and enforce our agreements

When data is no longer needed, we securely delete or anonymize it.

## **7. Data Protection & Security**

We use industry-standard security measures including:

- Encrypted data transmission (SSL/TLS)

- Secure servers and limited-access storage
- Regular system audits and monitoring

However, no online transmission is 100% secure. You acknowledge and accept these inherent risks by using our Services.
