This Privacy Policy explains how FSD-X ORB PRO ("FSD-X," "we," "us") handles information in connection with your use of our services through Whop and associated platforms.

SECTION 01

Information We Collect

When you subscribe to or use FSD-X ORB PRO, the following information may be collected:

- Your name and email address provided at signup
- Your Discord username when connected to our server
- Your TradingView username provided during onboarding
- Payment information processed securely by Whop
- General location data (country/region) provided by Whop

We do not collect sensitive financial data, trading account details, or any information beyond what is necessary to provide access to our service.

SECTION 02

How We Use Your Information

The information collected is used solely to:

- Verify and manage your membership access
- Confirm your TradingView and Discord accounts for indicator access
- Communicate important service updates or policy notices
- Enforce our Terms of Service, including account limitation policies
- Detect and prevent abuse of trial access or membership terms

We do not sell, rent, or share your personal information with third parties for marketing purposes.

SECTION 03

Third-Party Platforms

FSD-X ORB PRO operates through third-party platforms including:

- Whop — for membership management and payment processing
- Discord — for community access and member communication
- TradingView — for indicator access and delivery

Each of these platforms has its own privacy policy governing how they handle your data. We encourage you to review their respective policies. FSD-X is not responsible for data practices of these third-party platforms.

SECTION 04

Data Retention

We retain member information for as long as your membership is active. If your membership is terminated or cancelled:

- Your account data may be retained for a reasonable period for record-keeping and abuse prevention purposes
- Payment records are retained by Whop in accordance with their policies
- You may request deletion of any personally identifiable information we hold by contacting fsdxteam@gmail.com

We take reasonable steps to protect your information. However:

- No method of electronic transmission or storage is 100% secure
- FSD-X is not liable for unauthorized access to data held by third-party platforms
- You are responsible for maintaining the security of your own accounts
