

Terms of Service: 6 Figure AI Agency Launchpad

1. Acceptance of terms

By enrolling in the **6 Figure AI Agency Launchpad** course or joining its Whop community (the “Program”), you agree to these Terms of Service (“Terms”). If you do not agree, do not enroll or use the Program.
