1. INTRODUCTION

Trader U respects your privacy and is committed to protecting your personal information. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you use our Telegram community, services purchased through Whop, and related educational services.

2. INFORMATION WE COLLECT

2.1 Information You Provide

We collect information you provide when using our Services:

- **Telegram Account Information:** Username, user ID, profile information
- **Whop Account Data:** Purchase history, billing information (processed by Whop)
- **Communication Data:** Messages, posts, and content shared in Telegram
- **Support Inquiries:** Information provided when contacting support

2.2 Automatically Collected Information

- **Usage Data:** Activity logs, message frequency, participation
- **Device Information:** IP address, device type, operating system
- **Platform Data:** Information from Telegram and Whop APIs

3. HOW WE USE YOUR INFORMATION

- Provide, operate, and maintain our Services
- Process membership payments through Whop
- Enforce community rules and maintain safety
- Prevent fraud, chargebacks, and abuse
- Respond to support requests
- Comply with legal obligations

4. INFORMATION SHARING

4.1 We Do Not Sell Your Information

We do NOT sell, rent, or trade your personal information.

4.2 When We Share Information

- **Payment Processors (Whop):** For payment processing and subscription management
- **Telegram Platform:** As required to operate the community
- **Legal Requirements:** When required by law or to prevent fraud
- **Fraud Prevention:** Sharing chargeback/fraudster information with other communities to protect the industry

5. DATA SECURITY

We implement reasonable security measures to protect your information. However, no internet transmission is completely secure. You use our Services at your own risk.

6. DATA RETENTION

We retain your information as necessary to provide Services and comply with legal obligations. **Important:** If you are removed for violations or file a fraudulent chargeback, we may retain your information permanently to prevent future access and protect our community.

7. YOUR RIGHTS

Depending on your jurisdiction, you may have rights to:

- Access your personal information
- Request correction of inaccurate information
- Request deletion (subject to legal retention requirements)

8. THIRD-PARTY SERVICES

Our Services operate through Telegram and Whop. Your use of these platforms is subject to their respective privacy policies. We are not responsible for their privacy practices.

Trader U is not for individuals under 18. We do not knowingly collect information from minors.
