

# Terms of Service

## 1. Acceptance of Terms

By purchasing, accessing, or using any GeoboxAI service, you agree to be bound by these Terms of Service ('Terms'). These Terms form a legally binding agreement between you and GB Digital Systems Ltd ('GeoboxAI', 'we', 'us', 'our'). If you do not agree to these Terms, do not use the service.

These Terms are governed by the laws of England and Wales. Nothing in these Terms affects your statutory rights as a consumer under UK law, including the Consumer Rights Act 2015.

## 2. Description of Service

GeoboxAI provides digital automation and matchmaking assistance services for use with third-party gaming platforms. The service relies on third-party platform providers and infrastructure outside of GeoboxAI's ownership or control ('Third-Party Platforms').

The continued availability of GeoboxAI is dependent on these Third-Party Platforms remaining accessible. GeoboxAI makes no warranty that Third-Party Platforms will remain available, functional, or accessible at any time.

## 3. Membership Tiers

GeoboxAI offers membership plans including monthly, yearly, and Lifetime tiers. Each tier grants access to the service for its stated period, subject to the conditions in these Terms.

**Lifetime Membership:** A 'Lifetime' membership grants access to GeoboxAI for the operational lifetime of the service — defined as the period during which GeoboxAI is actively operated by GB Digital Systems Ltd. A Lifetime membership is not a guarantee of indefinite access and does not constitute a perpetual licence. In the event that GeoboxAI permanently discontinues service, Lifetime members will receive no fewer than 14 days' notice where reasonably practicable, and no further refund obligation will arise beyond that notice period.

*By purchasing a Lifetime membership, you acknowledge that access is provided for the operational lifespan of GeoboxAI and not for your personal lifetime or any fixed guaranteed duration.*

## 4. Third-Party Platform Dependency & Force Majeure

GeoboxAI's service is fundamentally dependent on access to third-party platform providers whose services, policies, and availability are outside GeoboxAI's control.

GeoboxAI shall not be liable, and no refund obligation shall arise, in the event that service is suspended, degraded, or permanently discontinued as a direct result of: (a) changes to the terms of service, policies, or technical infrastructure of any third-party platform provider; (b) bans, restrictions, or enforcement actions applied by any third-party platform provider to GeoboxAI's accounts or infrastructure; (c) discontinuation of any third-party platform, service, or game title that GeoboxAI's service depends upon; (d) any event outside GeoboxAI's reasonable control, including but not limited to acts of God, government action, cyberattacks, or regulatory changes.

Where a service disruption caused by the above results in a complete inability to provide the service for a continuous period exceeding 14 days, affected members may be offered a prorated credit or account extension at GeoboxAI's discretion.

## **5. Payments & Billing**

All payments are processed through Whop (Whop Inc.) or such other payment processors as GeoboxAI may use from time to time. By completing a purchase, you agree to Whop's Buyer Terms in addition to these Terms.

Subscription fees are billed in advance for the period selected. Lifetime memberships are a one-time payment. You are responsible for ensuring your payment details are kept up to date. GeoboxAI reserves the right to suspend access if payment cannot be processed.

## **6. Refunds & Cancellations**

Please refer to our separate Return & Refund Policy for full details. In summary: all sales are final once digital access has been granted, subject to your statutory rights and the exceptions set out in the Return & Refund Policy.

You may cancel a recurring subscription at any time via your Whop dashboard to prevent future billing. Cancellation stops future charges but does not entitle you to a refund of the current billing period already paid.

Initiating a chargeback or payment dispute without first contacting GeoboxAI support is a breach of these Terms and may result in immediate termination of your access.

## **7. Acceptable Use**

You may not resell, share, redistribute, or transfer your GeoboxAI access to any third party. Each membership is for personal use by a single user only.

You agree not to attempt to reverse engineer, copy, modify, or interfere with GeoboxAI's software, infrastructure, or systems.

GeoboxAI reserves the right to suspend or terminate your access without notice if we reasonably believe you are in breach of these Terms or are misusing the service.

## **8. Limitation of Liability**

To the maximum extent permitted by applicable law, GeoboxAI's total liability to you for any claim arising out of or in connection with your use of the service shall not exceed the amount you paid for your current membership period.

GeoboxAI is not responsible for any indirect, consequential, or incidental losses, including loss of gaming progress, account actions on third-party platforms, or any outcomes arising from use of the service.

Nothing in these Terms limits GeoboxAI's liability for death or personal injury caused by our negligence, fraud, or any other liability that cannot be excluded by law.

## **9. Modifications to Service & Terms**

GeoboxAI reserves the right to modify, update, or discontinue the service or any feature at any time. Where changes are material, we will endeavour to provide reasonable notice via the GeoboxAI Discord server.

We may update these Terms from time to time. The current version will always be available on our Whop page. Continued use of the service following an update constitutes acceptance of the revised Terms.

## **10. Governing Law**

These Terms are governed by the laws of England and Wales. Any disputes arising out of or in connection with these Terms shall be subject to the exclusive jurisdiction of the courts of England and Wales, without prejudice to your rights as a consumer under applicable law.
