

End User License Agreement (EULA)

The Creative Trader — Proprietary Trading Indicator | Effective July 3, 2026

This End User License Agreement ("Agreement") governs your use of the proprietary trading indicator (the "Software") licensed by Uncreative Capital LLC d/b/a The Creative Trader for use on TradingView. By accessing or using the Software, you agree to be bound by this Agreement.

1. License Grant

Subject to your compliance with this Agreement and payment of applicable fees, the Company grants you a limited, non-exclusive, non-transferable, revocable license to use the Software for your personal trading analysis, for as long as your subscription remains active.

2. Restrictions

You may not:

- Copy, reproduce, distribute, or share access to the Software with any third party.
- Reverse engineer, decompile, disassemble, or attempt to derive the source code, logic, or formulas underlying the Software.
- Modify, create derivative works from, or rebrand the Software.
- Resell, sublicense, rent, or lease the Software or access to it.
- Use the Software to build a competing product or service.

3. Ownership

The Software, including all underlying code, logic, and documentation, is and remains the exclusive property of Uncreative Capital LLC d/b/a The Creative Trader. This Agreement does not transfer any ownership rights to you.

4. Term & Termination

This license is coextensive with your active subscription. It terminates automatically and immediately upon cancellation, non-payment, or any breach of this Agreement or the Terms of Service, at which point you must cease all use of the Software.
