

# Beauty Business Breakthrough (BBB)

## Terms & Conditions

These Terms & Conditions apply to participation in **Beauty Business Breakthrough Inner Circle** and **Beauty Business Breakthrough Private Mentorship**, operated by **KR Beauty Academy**.

By enrolling in any BBB program, participants acknowledge that they have **read, understood, and agreed to these Terms & Conditions**.

## 1. Program Options

Participants may enrol in one of the following programs:

### **Beauty Business Breakthrough Inner Circle**

A membership-based community including access to:

- The BBB course
- Monthly group coaching calls
- Masterclasses
- Resource vault
- Community forum
- Call recordings

### **Beauty Business Breakthrough Private Mentorship**

An 8-week mentorship program including:

- Custom growth plan
- Four 1-1 mentorship calls
- Plug-and-play social media plan
- Access to the BBB course
- Access to the Inner Circle community during the mentorship period
- Continued Inner Circle access for three months after mentorship completion

Each program provides different levels of support and access.

## 2. Inner Circle Membership Commitment

Inner Circle membership is **\$99 per month** and requires a **minimum 12-month commitment**.

By enrolling, members agree to complete **all 12 monthly payments**, regardless of usage, attendance, participation, or engagement.

Failure to attend calls, access the course, or participate in the community **does not cancel or reduce payment obligations**.

At the end of the initial 12-month commitment period, members may choose to **renew their membership for another 12 months**.

Members who renew their membership will **retain their original pricing**.

If membership access **lapses after the initial 12-month period and the member later chooses to rejoin**, they will enrol at the **current advertised price at the time of re-joining**.

## 3. Private Mentorship Payment Options

Private Mentorship may be paid via:

- **Pay In Full (PIF)**
- **8-week payment plan**

By selecting a payment plan, participants agree to complete **all scheduled payments**.

Failure to attend mentorship calls, complete coursework, or participate in the program **does not cancel remaining financial obligations**.

## 4. Failed Payments

If a payment fails:

- Access to the program platform may be **temporarily suspended immediately**
- The system will **automatically attempt to process payment again within 24 hours**

If the payment is successfully processed, **access will be restored immediately**.

If payment remains unresolved, access may remain suspended until the outstanding balance has been cleared.

## 5. No Refund Policy

Due to the **digital nature of the programs and immediate access to materials**, all payments are **non-refundable**.

This applies to:

- Pay In Full purchases
- Payment plans
- Inner Circle memberships

Refunds will not be issued for:

- Change of mind
- Lack of participation
- Failure to attend calls
- Scheduling conflicts
- Failure to complete the course
- **Lack of results**

Participants are provided with tools, guidance, and education, however **results depend entirely on individual implementation, consistency, and effort**.

## 6. Course & Program Access

Participants receive access to the BBB course materials within the platform.

Course content may be **released progressively (drip-fed)** to encourage learning, implementation, and consistent progress.

**Private Mentorship participants receive lifetime access to the BBB course content**, including future course updates.

Private Mentorship participants will also receive **full access to all Inner Circle benefits during the 8-week mentorship program**, including:

- Group coaching calls
- Masterclasses
- Community forum
- Resource vault
- Call recordings

Private Mentorship participants will also receive **three months of Inner Circle access following the completion of their mentorship program.**

After this three-month period, continued access to the Inner Circle community and benefits requires an **active Inner Circle membership.**

## 7. Coaching Calls

Inner Circle members receive access to **live monthly group coaching calls and masterclasses.**

These calls will also be **recorded and uploaded for members who cannot attend live.**

Private Mentorship participants receive **four 1-1 mentorship calls** scheduled during the 8-week mentorship program.

If a participant needs to reschedule a 1-1 call, **a minimum of 24 hours notice is required.**

Missed calls or cancellations with less than 24 hours notice **may not always be able to be rescheduled.**

## 8. Additional Mentorship Support

Private Mentorship participants may request additional mentorship support after completing the initial 8-week program.

This may include:

- Additional 1-1 calls
- Extended mentorship support
- Continued strategic guidance

Additional mentorship will be **arranged separately**, and pricing will be determined based on the **level of support required**.

All existing **Terms & Conditions** will remain in place for any extended mentorship support **unless otherwise agreed in writing**.

## 9. Results Disclaimer

Results are **not guaranteed**.

Participants are provided with tools, strategies, and guidance based on real business experience. However, success depends on each participant's:

- Effort
- Implementation
- Consistency
- Business circumstances

Individual results will vary.

## 10. No Financial or Business Guarantees
