

TERMS OF SERVICE

Q1Tile Technologies LLC

Effective Date: January 2026

These Terms of Service (“Terms”) constitute a legally binding agreement between you (“User,” “you,” or “your”) and Q1Tile Technologies LLC, a Wyoming limited liability company (“Company,” “Q1Tile,” “we,” or “us”), governing your purchase of, access to, and use of all digital products, services, subscriptions, software access, analytics, educational materials, and private community access sold or delivered through third-party platforms, including but not limited to Whop and Discord (collectively, the “Services”).

By purchasing, accessing, or using any Services, you acknowledge that you have read, understood, and agree to be bound by these Terms.

All payments are processed through third-party platforms, including Whop. Q1Tile Technologies LLC does not store or process your payment information.

Delivery of Services occurs immediately upon access being granted. Once access is provided, the digital service is deemed fully delivered.

5. No Refunds; Final Sale

All sales are final and non-refundable to the fullest extent permitted by law. No refunds, credits, or exchanges will be provided for:

- Unused time
- Partial access periods
- Dissatisfaction
- Misunderstanding of the Services
- Platform outages or third-party actions

You are responsible for canceling subscriptions prior to renewal.

6. Chargebacks and Payment Disputes

Initiating a chargeback, payment dispute, or reversal after access has been granted constitutes a material breach of these Terms.

- Immediately terminate access
- Submit access logs, timestamps, IP data, and usage records
- Recover associated costs, fees, and damages where permitted by law

7. Suspension and Termination

We reserve the right, in our sole discretion, to suspend or permanently terminate access at any time for violations of these Terms, platform policies, or conduct deemed harmful, abusive, or disruptive.

Termination does not entitle you to any refund.

8. Limitation of Liability

To the fullest extent permitted by law, Q1Tile Technologies LLC shall not be liable for any direct, indirect, incidental, consequential, special, or punitive damages arising from or related to your use of the Services.
