## Terms and Conditions of Service

### 1. Acceptance of Terms

By accessing or using any service offered by StockShowCo ("Company," "we," "us," or "our"), you ("Client," "Subscriber," or "you") agree to be bound by these Terms and Conditions ("Agreement"). If you do not agree to all terms herein, you may not use our services. These terms constitute a legally binding agreement between you and StockShowCo, a business operating out of Caldwell, Idaho.

### 2. Description of Services

StockShowCo provides online platform and connection services to the livestock show industry, including but not limited to:

- Judge listing and placement services
- Vendor and photographer listing services
- Livestock show and fair promotional services
- Coaching, fitting, and jock listing services
- Private treaty animal sale listings
- Livestock transport listing services
- Personal booking and coordination services (Premier tier)

All services are provided as described at the time of purchase on our website. StockShowCo reserves the right to modify, update, or discontinue any service with reasonable notice to active subscribers.

### 3. Subscription Plans and Billing

#### 3a. Monthly Subscriptions

Most StockShowCo services are offered on a month-to-month subscription basis. By enrolling in a monthly subscription, you authorize StockShowCo to charge your payment method on a recurring monthly basis until the subscription is cancelled.

#### 3b. One-Time Fees

Certain services, including livestock show and fair listings, are offered as a one-time fee. One-time fee services are non-refundable once the service has been initiated or delivered.

#### 3c. Service Termination for Non-Payment

If your monthly subscription payment is declined, fails to process, or is cancelled for any reason, your access to all associated StockShowCo services will be immediately suspended or terminated. StockShowCo is not liable for any loss of business, opportunity, or exposure resulting from service termination due to non-payment. It is your responsibility to maintain a valid, active payment method on file.

### 3d. Cancellation

You may cancel your monthly subscription at any time by contacting StockShowCo directly. Cancellation takes effect at the end of the current billing cycle. No partial refunds will be issued for unused portions of a billing period.

## 4. Third-Party Transactions — No Liability

StockShowCo operates solely as a connection and listing platform. We are NOT a party to any transaction, agreement, contract, booking, sale, or exchange of funds between any two parties who connect through our platform, including but not limited to:

- Judge bookings between shows and judges
- Private treaty animal sales between buyers and sellers
- Service agreements between coaches, fitters, jocks and their clients
- Transport agreements between transporters and clients
- Vendor or photographer agreements with shows or exhibitors

All payments, contracts, negotiations and disputes arising from connections made through StockShowCo are solely between the contracting parties. StockShowCo assumes no responsibility or liability for any financial transactions, disputes, losses, damages, or claims arising from those relationships. Each party is responsible for conducting their own due diligence before entering into any agreement with another party found through our platform.

## 5. Refund Policy and Payment Disputes

### 5a. No Refund Policy

All fees paid to StockShowCo are non-refundable. By completing a purchase or initiating a subscription, you acknowledge and agree that you are not entitled to a refund for any reason, including but not limited to dissatisfaction with services, failure to use services, or cancellation of a subscription prior to the end of a billing cycle.

### 5b. Dispute Resolution

StockShowCo reserves the right to dispute any chargeback filed in bad faith and to provide this Agreement and transaction records to your payment provider as evidence. Clients who initiate chargebacks may have their accounts permanently suspended.

Please note: StockShowCo cannot contractually prevent you from exercising your rights with your bank or card issuer. However, this section documents our policy and your agreement regarding the proper process for addressing payment disputes.

## 6. Profiles, Content and Intellectual Property

StockShowCo's total liability to you for any claim arising from these terms or our services shall not exceed the total amount you paid to StockShowCo in the three (3) months preceding the claim.

This Agreement shall be governed by and construed in accordance with the laws of the State of Idaho, without regard to its conflict of law provisions. Any disputes arising under this Agreement shall be subject to the exclusive jurisdiction of the state and federal courts located in Canyon County, Idaho.

By using StockShowCo services, you acknowledge that we collect and use personal information as described in our Privacy Policy, which is incorporated herein by reference. We do not sell your personal information to third parties. Information provided through intake forms is used solely for the purpose of building and maintaining your professional profile and delivering our services.
