Our Policy

All fees paid to StockShowCo are final and non-refundable. By purchasing any StockShowCo service — whether a monthly subscription or a one-time fee — you acknowledge and agree that you are not entitled to a refund under any circumstances, including but not limited to:

- Dissatisfaction with the service or results
- Failure to use the service after purchase
- Cancellation of a monthly subscription prior to the end of a billing cycle
- Change of mind after purchase
- Failure to complete or submit your intake form after enrollment
- Technical difficulties on your end
- Low or no response from the platform during your subscription period
- Closure or suspension of your account due to a violation of our Terms and Conditions

StockShowCo is a service-based business. Upon purchase, we immediately begin allocating time, resources and platform access to your account. For this reason, all sales are final.

Monthly Subscriptions

Monthly subscribers may cancel at any time. Cancellation takes effect at the end of the current billing cycle. You will retain access to your services through the end of the paid period. No partial refunds or prorated credits will be issued for any unused days remaining in a billing cycle after cancellation.

If your payment is declined or fails to process, your services will be suspended immediately. Reinstatement of services requires resolution of the outstanding payment. StockShowCo is not responsible for any loss of exposure, bookings, or business opportunities during a suspension period resulting from non-payment.

One-Time Fees

Services purchased for a one-time fee — including but not limited to livestock show and fair listings — are non-refundable once the service has been initiated, delivered, or posted. This includes situations where the show, event or listing is cancelled after the service has been rendered by StockShowCo.

Exceptions

StockShowCo does not offer refunds. However, in the rare event of a billing error made on our part — such as a duplicate charge or an incorrect amount — please contact us within seven (7) days of the charge at info@stockshowco.com and we will investigate and correct the error promptly.

Billing errors are the only circumstance under which a credit or correction may be issued at the sole discretion of StockShowCo.

Payment Disputes and Chargebacks

If you have a concern regarding a charge from StockShowCo, we ask that you contact us directly before initiating a dispute with your bank or credit card issuer. We are committed to resolving legitimate concerns in good faith.

You acknowledge that filing a chargeback or payment reversal without first contacting StockShowCo to seek resolution may constitute a breach of our Terms and Conditions. StockShowCo reserves the right to provide this policy, your purchase records and our Terms and Conditions to your payment provider as evidence in any dispute. Accounts associated with chargebacks may be permanently suspended.
