

# PRIVACY POLICY

## Gold Rush Trading Software & Community

This Privacy Policy explains how **Capital Rush, LLC** (“Capital Rush,” “Company,” “we,” “us,” or “our”) collects, uses, stores, and protects information in connection with your access to and use of **Gold Rush** (the “Product”).

By accessing or using Gold Rush, you consent to the practices described in this Privacy Policy. If you do not agree, you must discontinue use of the Product.

## 1. INFORMATION WE COLLECT

We collect only information that is reasonably necessary to operate, secure, and improve Gold Rush.

### A. Information You Provide Directly

This may include:

- Full name
- Email address
- Account credentials and identifiers
- Communication with support or community moderators

### B. Payment & Subscription Information

- Payment processing, billing status, and subscription access are handled by **third-party platforms such as Whop**
- Capital Rush does **not** store full payment card details
- We may receive confirmation of payment status, plan tier, renewal dates, and access eligibility

### C. Usage & Technical Information

We may automatically collect:

- Login timestamps and access logs

- IP address and general device/browser data
- Platform interaction and feature usage
- Security and anti-abuse monitoring data

## D. Community Activity

If you participate in:

- Discord servers
- Group chats, voice calls, or screen shares

We may collect and review messages, activity logs, and moderation-related data to enforce rules and protect the community.

## 2. HOW WE USE YOUR INFORMATION

We use collected information strictly for legitimate business and operational purposes, including to:

- Provide and manage access to Gold Rush
- Verify eligibility and subscription status
- Maintain platform stability and security
- Monitor misuse, abuse, or policy violations
- Enforce Terms of Service and community rules
- Communicate updates, notices, or support responses
- Improve features, performance, and user experience

We do **not** use your information for unrelated purposes.

## 3. DATA SHARING & DISCLOSURE

Capital Rush does **not** sell, rent, or trade your personal information.

We may share limited information only under the following circumstances:

### A. Service Providers

We may share necessary data with trusted third-party providers, including:

- **Whop** (payment processing, access control, subscriptions)
- Community and infrastructure platforms required to operate Gold Rush

These providers may access data **only** to perform services on our behalf.

## **B. Legal & Compliance Obligations**

We may disclose information if required to:

- Comply with applicable laws, regulations, or legal process
- Respond to lawful requests from authorities
- Protect the rights, property, or safety of Capital Rush, users, or others
- Enforce our Terms of Service or investigate violations

## **4. DATA SECURITY**

We implement reasonable administrative, technical, and organizational safeguards to protect your information from unauthorized access, misuse, or disclosure.

However, you acknowledge that:

- No system is completely secure
- No method of transmission over the internet is 100% risk-free

By using Gold Rush, you accept these inherent risks.

## **5. DATA RETENTION**

We retain personal information only for as long as necessary to:

- Provide the Product
- Comply with legal and regulatory obligations
- Resolve disputes
- Enforce agreements

Some data may be retained after account termination where legally required or reasonably necessary for business or compliance purposes.

## **6. YOUR RIGHTS & REQUESTS**

Depending on applicable law, you may have the right to:

- Request access to personal data we hold about you
- Request correction of inaccurate information
- Request deletion of personal data

Requests are subject to:

- Identity verification
- Legal, regulatory, or contractual retention requirements

We reserve the right to deny requests where permitted by law.

## 7. THIRD-PARTY PLATFORMS

Gold Rush may rely on third-party platforms (including Whop and Discord) to operate. Your use of those platforms is subject to their own privacy policies and terms.

Capital Rush is **not responsible** for the privacy practices of third parties outside our direct control.

## 8. CHANGES TO THIS POLICY

We may update this Privacy Policy from time to time. Any changes will be effective upon posting with an updated “Last Updated” date.

Your continued use of Gold Rush after changes are posted constitutes acceptance of the revised policy.
