## 1. Scope

These Terms of Service ("Terms") govern purchases made from [GUILHERME CASAGRANDE CARRARO] ("Creator," "we," "us," or "our") through Whop, embedded checkout links, social media links, or related pages controlled by the Creator.

By completing a purchase, you agree to these Terms, the refund policy, the privacy policy, and any product-specific description shown at checkout. In the event of a conflict, the checkout page description controls for the specific item purchased, except where prohibited by law.

Whop provides the checkout and payment infrastructure, but the Creator is solely responsible for the content, support, delivery, and policies relating to the Creator offering.

## 2. What the customer is buying

Unless the checkout page clearly states otherwise, the customer is making a voluntary paid tip to support the Creator and the Creator's artistic work, online content, and audience community. A tip on this page is not a charitable donation, is not tax-deductible, and does not create any ownership, equity, profit-sharing, or investment rights.

If the checkout page expressly lists a perk, access benefit, downloadable digital item, or membership feature, the customer receives only the specific access or item described there. No other deliverables, timelines, one-to-one services, custom work, or guaranteed responses are included unless expressly stated in writing on the checkout page.

All offerings are personal-use creator support products unless expressly labeled otherwise.

## 3. Eligibility and buyer representations

You must be legally able to enter into a binding transaction in your jurisdiction and to use Whop under applicable law and platform rules.

You represent that the payment method used is yours or that you are authorized to use it, and that all billing information you provide is accurate and current.

You may not purchase or use the Creator offering for any unlawful purpose, to harass the Creator, to infringe intellectual property rights, or to obtain access by fraud, chargeback abuse, account sharing, scraping, or other unauthorized means.

## **4. Content, conduct, and prohibited use**

The customer may not use the Creator offering, private messages, downloadable content, or any related community spaces to post, request, transmit, promote, or distribute illegal content, hateful content, threats, malware, non-consensual intimate content, sexual exploitation material, content inappropriate for minors, or infringing material.

The customer may not reproduce, redistribute, resell, record, leak, mirror, sublicense, or commercially exploit paid content, private access, or downloadable assets except where the Creator gives prior written permission.

Any abusive, deceptive, or policy-violating use may result in suspension or termination of access without prejudice to any refund rights required by law.

## **5. Intellectual property and license**

All content, artwork, branding, text, graphics, posts, videos, downloads, and other materials supplied by the Creator remain the property of the Creator or the applicable rights holder.

Subject to payment and continued compliance with these Terms, the Creator grants the buyer a limited, non-exclusive, non-transferable, revocable license to access or view the purchased content for personal, non-commercial use only.

No license is granted to use the Creator name, likeness, logo, or content for AI training, commercial resale, print-on-demand, NFTs, tokenization, dataset creation, scraping, or redistribution unless the Creator gives express written consent.

## **6. Delivery and access**

Access is typically delivered through Whop, email, a link on the confirmation page, or another method stated at checkout. The customer is responsible for using a valid email address, monitoring purchase confirmations, and contacting support if access is not received.

The Creator may update, improve, replace, or retire content, perks, community features, or bonus materials from time to time, provided the core purchased access is not materially misrepresented.

Temporary interruptions may occur due to platform outages, moderation actions, account verification, payment review, maintenance, force majeure, or circumstances outside the Creator's reasonable control.

## **7. Pricing, renewals, and billing**

Prices, currencies, billing intervals, and any included benefits are shown at checkout. The customer is responsible for reviewing the checkout details before purchase.

If a product is sold on a recurring basis, the subscription renews automatically at the stated interval unless canceled before the next billing date. Cancellation stops future renewals only and does not retroactively cancel the current paid period, except where required by law or under the refund policy.

The Creator does not guarantee any personal outcome, audience growth, monetary result, emotional benefit, or specific response time unless expressly promised in writing at checkout.

## **9. Chargebacks, fraud, and enforcement**

If you believe a transaction was unauthorized or a delivery problem occurred, contact the Creator first and use Whop's Resolution Center where available. Bank disputes should be used only where appropriate and truthful.

The Creator may keep and submit transaction records, IP logs, support messages, access logs, delivery records, download logs, community records, and other evidence to Whop, payment processors, or financial institutions to contest fraudulent or abusive chargebacks.

The Creator reserves the right to suspend access, cancel orders, or refuse future sales where fraud, abuse, policy evasion, account sharing, or material misrepresentation is reasonably suspected.
