

# End User License Agreement

A1 Trades | Effective Date: June 9, 2026

This End User License Agreement ("EULA") is a legal agreement between you ("User," "you," or "your") and A1 Trades ("A1 Trades," "we," "us," or "our") governing your use of the digital content, materials, tools, and resources made available to you through our membership on Whop, Discord, akitrades.com, and related channels (collectively, the "Licensed Materials").
