

# Privacy Policy

This Privacy Policy explains how A1 Trades ("we," "us," or "our") collects, uses, and protects information when you access our community, content, and services through Whop, Discord, akitrades.com, and related channels (collectively, the "Services").

## 1. Information We Collect

### a. Information You Provide

- Name, email address, and contact details provided when you sign up, purchase a membership, or contact us
- Payment information processed through Whop and its payment processors (we do not directly store your full payment card details)
- Messages, comments, and content you post within our Discord community or via our contact forms

### b. Information Collected Automatically

- Usage data such as pages visited, videos viewed, and engagement with our content
- Device and browser information, IP address, and general location data
- Cookies and similar tracking technologies used on our website and checkout pages

## 2. How We Use Your Information

- To provide, operate, and maintain the Services, including delivering trade alerts, content, and community access
- To process payments, manage subscriptions, and handle billing through Whop
- To communicate with you about your membership, updates, promotions, and support requests
- To improve our content, website, and overall member experience
- To detect, prevent, and address fraud, abuse, security issues, or violations of our Terms of Service

## 3. How We Share Your Information

We do not sell your personal information. We may share information with:

- Service providers such as Whop (payment processing and membership management) and Discord (community hosting)
- Analytics and marketing platforms used to understand traffic and improve our Services
- Law enforcement or regulators when required by law or to protect our rights and the safety of our community

## 4. Cookies and Tracking

Our website (akitrades.com) may use cookies and similar technologies to remember your preferences, analyze site traffic, and improve functionality. You can control cookie preferences through your browser settings.

## 5. Data Retention

We retain your information for as long as necessary to provide the Services, comply with legal obligations, resolve disputes, and enforce our agreements. You may request deletion of your personal information as described below, subject to legal and contractual retention requirements.

## 6. Your Rights

Depending on your location, you may have rights to:

- Access the personal information we hold about you
- Request correction or deletion of your personal information
- Opt out of marketing communications at any time
- Withdraw consent where processing is based on consent
