By joining The Collective — whether on a free trial or paid membership basis — you agree to the following terms and conditions. Please read them carefully before proceeding.

1. About The Collective

The Collective is a paid membership community run by Jade Beason (trading as The Creator Project). It provides access to community spaces, resources, content, and events as outlined on our website [thecreatorproject.com]. The features and content available are subject to change at our discretion.

2. Free Trial

Where a free trial is offered:

The free trial period is 7 days from the date of sign-up.

During the free trial, access is provided to the community space only. Certain tools, resources, and features are reserved for paid members and will not be accessible during the trial period.

If you do not cancel before the trial period ends, your membership will automatically renew at the standard monthly rate and payment will be taken.

It is your responsibility to cancel before the trial ends if you do not wish to be charged.

3. Billing & Payment

Membership is billed on a monthly recurring basis.

Payment is taken automatically on your renewal date each month via the payment method provided at sign-up.

All prices are listed on our membership page and are subject to change. We will notify you of any price changes in advance.

Payments are processed securely through our platform provider, Whop.

4. Cancellation

You may cancel your membership at any time. To cancel:

Log into your Whop account and cancel via your membership dashboard, OR

Contact us at hello@thecreatorproject.com and we will process the cancellation on your behalf.

Cancellation takes effect at the end of your current billing period. You will retain access to the community until that date.

5. Refund Policy

All membership payments are non-refundable once processed.

We do not offer refunds for charges that have already been taken, including in cases where a member has forgotten to cancel before renewal.

Refunds will not be issued for partial months of membership.
