

## Terms and Conditions for SwingVault Alerts Services *(Educational Telegram Alerts Service)*

**Effective Date: April 2026**

**PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY BEFORE JOINING OR USING OUR SERVICE.** By accessing, joining, or using our, Telegram channel, alerts, signals, discussions, or any related content (collectively, the “SwingVault”), you agree to be bound by these Terms and Conditions. If you do not agree, do not join or use the Service.

### 1. Acceptance of Terms
