

End User License Agreement (EULA)

This End User License Agreement ("Agreement") is a binding legal agreement between you ("User" or "you") and Magma Indicators ("Company," "we," "us," or "our") operating via Magmagoldsignal.com.

By downloading, installing, accessing, or using the Magma Indicators software, including any updates, associated media, or documentation (collectively, the "Software") for the NinjaTrader platform, you agree to be bound by the terms of this Agreement. If you do not agree to the terms of this Agreement, do not download, install, or use the Software.

1. **Grant of License** Subject to your compliance with this Agreement and your continuous payment of the required subscription fees through Whop, Magma Indicators grants you a revocable, non-exclusive, non-transferable, limited license to download, install, and use the Software solely for your personal, non-commercial trading purposes on a single NinjaTrader Machine ID at any given time.

2. **License Restrictions** You agree not to, and you will not permit others to:

- **Copy or Distribute:** Reproduce, duplicate, copy, sell, resell, or exploit any portion of the Software.
- **Modify or Reverse Engineer:** Decompile, disassemble, reverse engineer, or attempt to reconstruct, identify, or discover any source code, underlying ideas, or algorithms of the Software.
- **Create Derivative Works:** Modify, translate, or create derivative works based on the Software.
- **Share Access:** Rent, lease, lend, share, or otherwise transfer your license or access to the Software to any third party. Your license is tied directly to your individual Whop account and NinjaTrader Machine ID.
- **Bypass Security:** Attempt to bypass, disable, or circumvent any licensing servers, encryption, or security features embedded within the Software.

3. **Intellectual Property Rights** The Software, including all code, algorithms, visual interfaces, graphics, design, and associated documentation, is the exclusive property of Magma Indicators and is protected by copyright and other intellectual property laws. This Agreement does not grant you any ownership rights in the Software.

4. **Subscription and Authentication** Access to the Software requires an active, paid subscription processed through our third-party provider, Whop.

- The Software periodically communicates with our licensing servers to verify your active subscription status using your NinjaTrader Machine ID.

- If your subscription expires, is canceled, or fails to renew, your access to the Software will be automatically revoked.

5. Updates and Modifications Magma Indicators reserves the right to modify, update, or discontinue the Software (or any features within it) at any time, with or without notice. We may provide updates or patches to the Software, which will be governed by this Agreement unless accompanied by a separate license.
