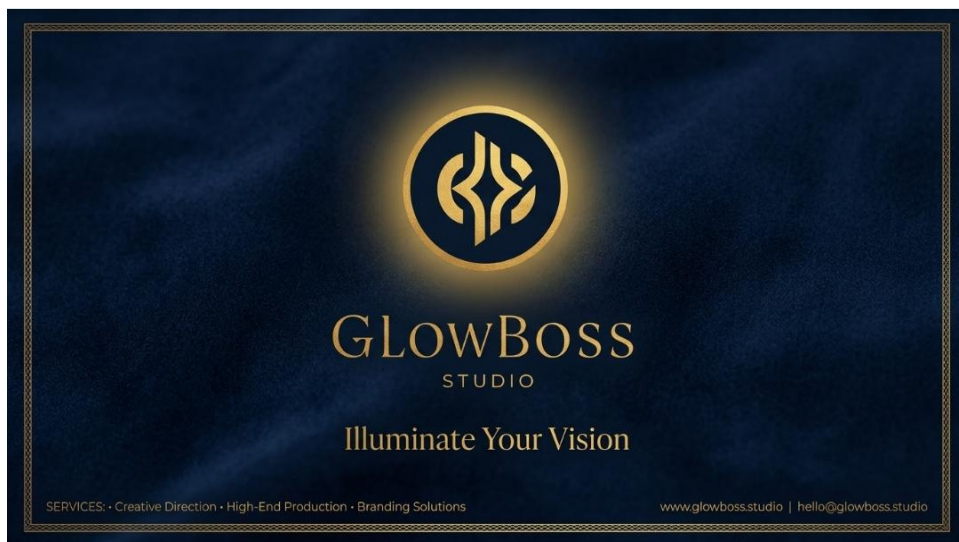




TERMS OF SERVICE

GlowBoss Studio

1. Agreement to Terms

3. Payments & Fees

- Payments are processed securely through Whop's payment infrastructure.
- All sales are final unless otherwise stated in the specific service agreement.
- GlowBoss Studio reserves the right to update pricing at any time; existing orders will not be affected by price changes.
- For subscription-based services, you authorize recurring billing until cancelled.

4. Refund & Cancellation Policy

- Refunds are not issued once creative work has commenced.
- Cancellations made within 24 hours of purchase and before any work has begun may be eligible for a full refund at our discretion.

- Clients may not resell, redistribute, or claim ownership of GlowBoss Studio's proprietary processes, templates, or methodologies.
