

# End User Licence Agreement (EULA)

Effective date: 19 May 2026

This End User Licence Agreement governs the licence granted to access and use digital course materials, community access features, and downloadable resources made available through The AI Shorts Method. The licence is provided in connection with the official Whop page and associated Discord community.[cite:1]

## 1. Licence grant
