

Terms of Service

Effective date: 19 May 2026

These Terms of Service govern access to and use of The AI Shorts Method, including the Whop listing at <https://whop.com/the-ai-shorts-method>, associated Discord community access, digital course materials, and downloadable resources. These terms are governed by the laws of England and Wales.[web:70]

1. About the service

The AI Shorts Method provides educational resources about creating AI YouTube Shorts, including course content, community access through Discord, and certain digital downloads. Access may be offered on a monthly, yearly, or lifetime basis, depending on the membership selected by the customer.[cite:1]

2. Acceptance of these terms

By purchasing, accessing, or using the service, the user agrees to these Terms of Service and any related policies made available through the Whop page or community spaces. Users who do not agree should not access or use the service.[cite:1]
