1. Overview

Transacbo ("we," "us," or "our") is committed to protecting your privacy. This Privacy Policy explains what data we collect, how we use it, and your rights regarding that data.

2. Information We Collect

2.1 Account Information

When you subscribe via Whop, we receive:

- Your name and email address
- Payment confirmation (we do not store card details -- Whop handles payments)
- License/membership status

2.2 Software Usage Data

The Transacbo desktop application may collect:

- License key validation requests (to verify active subscriptions)
- Software version and OS type (for compatibility)
- Crash reports or error logs (if you opt in)

2.3 Trading Data

- Transacbo connects to your brokerage (e.g., Interactive Brokers) directly on your local machine.
- Your brokerage credentials and trading account data are never transmitted to our servers.
- All trade execution happens locally between the Software and your broker.

2.4 Communications

If you contact us by email, we retain that correspondence to respond to your inquiry.

3. How We Use Your Information

We use your information to:

- Validate and manage your subscription
- Deliver software updates and notifications
- Respond to support requests
- Improve the Software based on aggregate usage patterns

- Comply with legal obligations

We do not sell, rent, or share your personal data with third parties for marketing purposes.

4. Data Sharing

We may share your data only with:

- Whop (our payment and licensing platform) -- to manage your subscription
 - Legal authorities -- if required by law or to protect our legal rights

5. Data Storage and Security

- Account and subscription data is stored securely by Whop.
 - We implement reasonable technical measures to protect any data we hold.
 - No system is 100% secure; use the Software at your own risk.

6. Your Rights
