- We are not a sportsbook, broker, or financial advisor
- You must be of legal age to participate in sports betting in your jurisdiction

2. Product Delivery

All products are **digital products delivered instantly** upon purchase. Once your payment is processed, you will receive immediate access to the purchased content through the Whop platform. Delivery is considered complete at the time access is granted, regardless of whether you view or use the content.

3. Refund Policy — All Sales Are Final

All purchases are final and non-refundable. Because our products are digital content delivered instantly upon purchase, we do not offer refunds for any reason, including but not limited to:

- Picks that result in a loss
- Dissatisfaction with pick outcomes or performance
- Failure to view or use the content before it expires
- Forgetting to cancel a subscription before renewal
- Change of mind after purchase
- Inability to place bets due to not having a sportsbook account
- Not understanding how to use the product

4. Subscription Terms
