

Terms of Service

1. Provider and scope

These Terms of Service govern the purchase and use of the digital products offered under the brand “1M Frame” by Marius Haug, Hochvogelweg 18, 84034 Landshut, Germany (the “Provider”, “we”, “us”), sold via the Whop platform. By completing a purchase you agree to these Terms.

2. Products

1M Frame products are digital goods (e.g. spreadsheet journals, a Notion template, a coaching package, and access to a web app). They are delivered electronically, either as a download/file or as access to an online product, immediately or shortly after purchase.

3. Prices and payment

All prices are shown at checkout in the stated currency and are final. As a small business under sec. 19 UStG, we do not charge or show value-added tax. Payment is processed by Whop and its payment providers; we do not store your card details.

4. Contract formation and delivery

A contract is formed when your purchase is confirmed by Whop. You then receive access to, or the download of, the purchased product. Please keep your purchase confirmation.

5. Right of withdrawal for digital content

For digital content supplied on a non-tangible medium, your statutory right of withdrawal expires once performance has begun - i.e. once you have requested immediate access/download and acknowledged that you thereby lose your right of withdrawal. Independently of this, we offer a voluntary 30-day money-back guarantee; see our Refund Policy.

6. License and permitted use

Your purchase grants you a personal, non-exclusive, non-transferable license to use the product for your own use. You may not resell, redistribute, share, sublicense or publish the products or their contents. Full terms are set out in the End User License Agreement (EULA).

7. Educational purpose - no financial advice

1M Frame products are educational tools for trading discipline, journaling and self-review. They do not constitute financial, investment, tax or trading advice, and no specific result, profit or performance is promised or guaranteed. Trading financial instruments carries a substantial risk of loss. You alone are responsible for your trading decisions and their outcomes.

8. Availability

For app-based products we aim for continuous availability but do not guarantee uninterrupted access; maintenance, updates or third-party outages may cause temporary interruptions.

9. Limitation of liability

We are liable without limitation for intent and gross negligence and under mandatory law (including the

German Product Liability Act) and for injury to life, body or health. For slight negligence we are liable only for breach of a material contractual obligation, and limited to the foreseeable, typical damage. Any further liability is excluded.

10. Governing law and place of jurisdiction

German law applies, excluding the UN Convention on Contracts for the International Sale of Goods. Mandatory consumer-protection provisions of your country of residence remain unaffected. Where permitted, the place of jurisdiction is Landshut, Germany.
