

Voss Trading Education Terms of Service

1. Introduction

Welcome to Voss Trading Education (“VTE,” “we,” “our,” or “us”). These Terms of Service (“Terms”) govern your access to and use of all VTE services, including but not limited to:

- WHOP communities
- Discord servers
- Zoom calls

By accessing or using VTE, you acknowledge that you have read, understood, and agreed to be bound by these Terms.

2. Educational Purpose Only

Violation of these rules may result in suspension or permanent removal without refund.

4. Content Guidelines

Users may share market-related educational discussions so long as the content is lawful, respectful, and non-misleading.

The following content is prohibited:

- illegal or fraudulent content
- obscene, defamatory, or harmful material
- investment solicitations
- trade alerts or copy-trading instructions
