

END USER LICENSE AGREEMENT (EULA)

Last Updated: July 14, 2026

This End User License Agreement (hereinafter referred to as the "Agreement") is a legal agreement between you (an individual, hereinafter the "User") and Una Sola Hora / @UnaSolaHora / UnaSolaHora.com (hereinafter the "Licensor"), the owner of the membership and digital products distributed through the Whop platform under the brand unasolahora.com (hereinafter the "Service").

By purchasing, accessing, or using the membership, materials, content, tools, or community channels of the Service, you agree to be bound by the terms of this Agreement. If you do not agree, do not purchase or use the Service.

1. GRANT OF LICENSE

The Licensor grants you a limited, non-exclusive, non-transferable, revocable license for strictly personal and non-commercial use to access and use the content, strategies, tools, and community of unasolahora.com in accordance with the terms set forth herein.

2. RESTRICTIONS ON USE

The User agrees NOT to perform, nor allow third parties to perform, the following actions:

Distribution and Resale: Copying, sharing, redistributing, selling, sublicensing, renting, or transferring any content, text materials, videos, guides, or resources obtained through the membership to anyone outside of it.

Shared Access: Sharing Whop account login credentials or exclusive access links to private communities (such as Discord, Telegram, or other platforms). Each membership is strictly personal and individual.

Reverse Engineering: Attempting to decompile, extract the source code, or replicate the tools and digital systems owned by the Licensor.

3. INTELLECTUAL PROPERTY

All intellectual property rights, trademarks, logos (including the stopwatch and growth arrow logo), copyrights, strategies, and materials of the Service are and shall remain the exclusive property of the Licensor. This Agreement does not transfer any ownership rights of the content to the User.

4. PAYMENTS, SUBSCRIPTION, AND CANCELLATIONS

Payment Processing: All payments and membership management are securely processed through the Whop platform.

Automatic Renewal: By subscribing, you agree that membership charges will be made on a recurring basis according to your chosen period (monthly, quarterly, annual).

Cancellation: The User can cancel their subscription at any time directly from their Whop user dashboard. Cancellation will stop future billing but does not entitle the User to refunds for periods already billed, unless otherwise provided by local law.

5. DISCLAIMER OF WARRANTIES AND LIMITATION OF LIABILITY

The Service and all its content are provided "as is", without warranties of any kind, either express or implied.

The Licensor does not guarantee specific results (financial, professional, or personal) derived from applying the strategies of unasolahora.com. Success depends exclusively on the User's execution and effort.

To the maximum extent permitted by law, the Licensor shall not be liable for any indirect, incidental, or consequential damages arising out of the use or inability to use the Service.

6. TERMINATION

This Agreement is effective until terminated. The Licensor reserves the right to immediately revoke access to the Service and terminate this license without prior notice if the User breaches any terms of this Agreement (such as leaking exclusive material or piracy).

7. GOVERNING LAW AND JURISDICTION

This Agreement shall be governed by and construed in accordance with the laws of Tennessee, United States of America, without giving effect to any principles of conflicts of law. Any dispute related to this Agreement shall be submitted to the competent courts of Montgomery County, Tennessee, USA.
