- **Payment Information:** Payment card details are collected and processed by third-party processors. We do not store full credit card numbers on our servers.
- **Usage Data:** Information about how you interact with our services, pages visited, and content viewed.

## 3. Marketing & How We Share Your Information

We use the information you share across our platforms for **marketing and promotional purposes**:

- **Social Proof & Community Highlights:** We may feature screenshots of community posts, trade results, charts, or YouTube comments in our promotional materials, including

YouTube videos and social media. These may include your **platform username** and **profile image**.

- **Personal Privacy:** We do not share private personal information (such as real names, addresses, or emails) in these materials unless that information is part of your public platform username.
- **Permission for Real Names/Photos:** When feasible, we will contact users directly to seek express permission before using a user's real name or provided portrait photography in marketing materials.
- **Email Marketing:** We may use your email to inform you about Stock Moe products or related third-party services. You may opt-out at any time via the "unsubscribe" link or by emailing: **support@stockmoe.com**.
- **Service Fulfillment:** We share necessary data with platforms like **Whop**, **Discord**, and **TradingView** to deliver your purchased products and whitelisting access.
