END USER LICENSE AGREEMENT

This End User License Agreement (the "**EULA**") applies to digital products licensed by **PixelBytesLab**, including templates, printables, resource libraries, files, digital toolkits, Notion resources, prompt packs, spreadsheets, guides, and other digital assets. A product page may grant additional rights; where it does, the product-specific license controls.

1. License Grant

Subject to payment of any required fee and compliance with this EULA, PixelBytesLab grants the purchaser a limited, non-exclusive, non-transferable, non-sublicensable license to access, download, use, and reasonably customize the purchased product for the purchaser's own personal use or internal business use.

2. What You May Do

- Use the product for your own personal projects or internal business workflows.

3. What You May Not Do
