Terms of Use, Privacy Policy, Refund Policy & License Agreement

Welcome to GLO Sports. This page outlines the terms that apply when you use our service. By signing up, subscribing, or accessing GLO Sports in any way, you agree to everything below. If you don't agree, please don't use the service.

GLO Sports is operated by Bellgreen Sports LLC, a Georgia limited liability company. Throughout this document, "we," "us," and "our" refer to Bellgreen Sports LLC d/b/a GLO Sports. "You" and "your" refer to you, the user.

The service is delivered through the Whop platform and Discord. These terms apply regardless of how you access it.

Terms of Use

Eligibility

You must be at least 18 years old and legally able to enter into agreements in your jurisdiction. By using GLO Sports, you confirm that you meet these requirements.

What **\$(DBA)** Is

GLO Sports is a paid online community that provides sports-related commentary, analysis, picks, educational content, and community discussion. The service is delivered primarily through Discord and the Whop platform.

Important: GLO Sports is not financial advice, investment advice, or gambling advice. Everything we provide is for informational and entertainment purposes only.

You acknowledge that no content in GLO Sports should be treated as a recommendation to place any bet or wager. All betting and wagering decisions are made entirely at your own risk. Past results shared in the community are not indicative of future outcomes. We are not licensed financial advisors, investment advisors, or gambling consultants. You are solely responsible for complying with all laws in your jurisdiction regarding sports betting.

Subscriptions & Payments

Access to GLO Sports requires a paid subscription through Whop. We may offer multiple products, tiers, or pricing options — each with its own features and fee structure as displayed on the applicable Whop listing at the time of purchase.

Subscriptions renew automatically on a recurring basis unless you cancel before your next billing cycle. All payment processing is handled by Whop and its payment processors. We do not directly store your payment card information.

We reserve the right to change pricing with 30 days' notice. Price changes apply to your next renewal, not your current cycle.

Free Trials

We may offer a free trial at our discretion. If you don't cancel before the trial ends, your subscription automatically converts to a paid plan and your payment method is charged. Free trials are limited to one per person, household, and payment method.

Rules of Use

When using GLO Sports, you agree not to:

- Share, redistribute, resell, or leak any content, picks, analysis, or alerts to anyone outside the community
- Use bots, scrapers, or automated tools to access or interact with the service

- Reverse-engineer, decompile, or disassemble any tools or software we provide
- Harass, threaten, or abuse other members or staff
- Impersonate any person or entity
- Post unlawful, harmful, defamatory, or obscene content in community channels
- Use the service for any unauthorized commercial purpose
- Circumvent or interfere with security features of the service
- Introduce viruses, malware, or other malicious code

You keep ownership of what you post, but by posting it you grant us a non-exclusive, worldwide, royalty-free, perpetual license to use, reproduce, modify, and display that content in connection with operating and promoting GLO Sports.

We're not responsible for the accuracy or quality of any content posted by other members. We reserve the right to remove any user content at any time, for any reason, without notice.

No Guarantees

The service is provided "as is" and "as available." We make no warranties of any kind — express or implied — about the accuracy, completeness, or reliability of any content.

We do not guarantee results, outcomes, or profits. Sports betting involves risk, and you may lose money. We disclaim all warranties including merchantability, fitness for a particular purpose, and non-infringement.

Limitation of Liability

Our total liability to you for any claim related to the service is capped at the amount you paid us in the three (3) months before the event giving rise to the claim.

Indemnification

You agree to indemnify and hold harmless Bellgreen Sports LLC, its owners, officers, employees, and affiliates from any claims, damages, losses, or expenses (including legal fees) arising from your use of the service, your violation of these terms, your violation of any law, any betting losses, or any content you post.

Termination

We may suspend or terminate your access at any time, with or without cause, and with or without notice. Reasons include but aren't limited to: violating these terms, abusing the service, fraudulent activity, or conduct harmful to the community.

When your access is terminated, your right to use the service ends immediately. No refunds are issued for any remaining subscription time.

Changes to These Terms

We may update these terms at any time. If we make material changes, we'll notify you through the service or by email. Continuing to use GLO Sports after changes are posted means you accept the updated terms.

Disputes & Arbitration

Please read this carefully. It affects your legal rights.

You and Bellgreen Sports LLC agree to resolve any disputes through binding individual arbitration rather than in court. Either party may seek injunctive relief for intellectual property claims. Arbitration is conducted by the American Arbitration Association under its Commercial Arbitration Rules, in the State of Georgia.

Class Action Waiver: You agree to bring disputes only in your individual capacity, not as part of any class, consolidated, or representative action.

Governing Law

These terms are governed by the laws of the State of Georgia, without regard to conflict of law provisions. If litigation is permitted, exclusive venue is the state and federal courts in Georgia.

General

If any part of these terms is found unenforceable, the rest remains in effect. These terms are the entire agreement between you and Bellgreen Sports LLC regarding the service. Our failure to enforce a provision isn't a waiver of it. You can't assign your rights under these terms without our consent; we can assign ours freely. We're not liable for delays or failures caused by events beyond our reasonable control.

Privacy Policy

Bellgreen Sports LLC d/b/a GLO Sports is committed to protecting your privacy. This section describes what information we collect, how we use it, and your choices.

Information We Collect

Information you provide:

Name, email address, Discord username and user ID, Whop account information, billing details (processed by our third-party payment processor), and anything else you voluntarily share.

Information collected automatically:

IP address, device and browser type, operating system, access times, pages viewed, referral URLs, and general location data derived from your IP.

Information from third parties:

We may receive data from Whop, Discord, and payment processors as needed to provide the service.

How We Use Your Information

We use your information to provide, maintain, and improve the service; process payments; communicate with you about your account; enforce our terms and prevent fraud; analyze usage to improve the experience; and comply with legal obligations.

How We Share Your Information

We do not sell your personal information.

We may share data with service providers (Whop, Discord, Stripe, email and analytics providers) who are contractually obligated to use it only for providing services to us. We may also disclose information if required by law, or in connection with a merger, acquisition, or sale of assets.

Data Retention

We keep your information as long as your account is active or as needed to provide the service. After termination, we'll delete or anonymize your data within a reasonable timeframe, except where retention is legally required.

Security

We use commercially reasonable safeguards to protect your information, but no system is perfectly secure. You're responsible for keeping your account credentials confidential.

Your Rights

Depending on your jurisdiction, you may have rights to access, correct, delete, or port your data. Contact us at info@glosportsgroup.com to exercise these rights.

You can opt out of promotional emails using the unsubscribe link in any message. We may still send transactional or account-related communications.

Children's Privacy

GLO Sports is not intended for anyone under 18. We don't knowingly collect information from minors. If we learn we've collected such data, we'll delete it promptly.
