Terms of Service, Risk Disclosure & Community Guidelines

By joining the Boost World Discord community, starting the 7-day free trial, subscribing, or accessing any picks, strategies, promos, discussions, or content, **you acknowledge that you have read, understood, and agree to these entire Terms.**

1. Eligibility

You must be of legal age to participate in sports betting, gambling, or sweepstakes-style gaming activities in your jurisdiction. While many traditional sportsbooks require users to be 21 or older, some sweepstakes, social casino, or promotional apps allow participation starting at 18.

By using our services, you confirm that you meet the minimum legal age requirement in your location. We strongly recommend that all members be 21 or older and practice responsible betting regardless of the platform they use.

Geographic Availability: Boost World services and content are only available to individuals physically located within the United States. By using our services, you confirm that you are located in the United States and that accessing this content complies with all applicable laws in your jurisdiction.

2. What Boost World Provides

Boost World is an educational Discord community focused on +EV (positive expected value) sports betting, mathematically profitable strategies, bankroll management, promotions, and long-term edge hunting. We share our data-driven approach and transparently track our own personal betting results for accountability. Access includes community discussion, insights, and picks. This is not a service that guarantees profits, winning records, or positive outcomes.

3. Critical Risk Disclosure – Read This Carefully

Sports betting carries financial risk. It is possible to lose money, including your entire bankroll.

Our transparently tracked personal betting results since February 2022 reflect past performance only. Past results (including any tracked profits or win rates) are not indicative of future results. Variance is real: you can (and likely will) experience losing days, weeks, months, or longer periods even when pursuing a positive edge. The mathematical edge we pursue plays out over large sample sizes, which means short-term results can vary significantly.

Individual results will vary based on factors such as bankroll size, available sportsbooks in your state, odds shopping, bet execution, and timing. Our tracked results reflect our personal betting only and should not be expected to match any individual member's outcomes.

Additionally, because we focus on betting with a mathematical edge (similar to advantage play or card counting in other forms of gambling), sportsbooks may identify sharp or professional-level betting activity. This can result in account restrictions such as promo bans, reduced maximum bet sizes, or limited betting options. These outcomes are outside of our control. We are not responsible for any account limitations, bans, or changes in terms imposed by sportsbooks as a result of following our strategies.

Everything shared (bets, picks, promos, strategies, analysis) represents opinions and analysis based on data available at the time. It is provided for informational and educational purposes only.

There are no guarantees of profits, winning records, or specific outcomes. Line movement, injuries, officiating, weather, and randomness mean anything can happen day to day, week to week, or month to month.

You are solely and entirely responsible for every betting decision you make, the size of your bets, your bankroll management, and all resulting profits or losses.

Only risk money you can afford to lose completely. We strongly encourage responsible gambling, including setting strict limits and never chasing losses.

4. Bankroll Management & Your Responsibility

Any bet sizes or unit suggestions we share reflect our personal bankroll and risk tolerance (we maintain significant capital dedicated to sports betting). If your bankroll is smaller, you must scale your bets down proportionally. Never overexpose yourself. You are fully responsible for your own staking plan and money management.

Our suggested bet sizes and unit recommendations are generally based on approximately 1% of bankroll. As your bankroll grows or shrinks, you are responsible for adjusting your unit size accordingly to maintain proper risk management.

5. Your Ongoing Responsibilities

- Always do your own research and verify everything independently. Odds and lines change quickly.
- Triple-check your Discord notification settings and actively monitor the server. We are not responsible for missed picks or updates due to your device, settings, or technical issues.
- Comply with all laws in your jurisdiction regarding sports betting and gambling.
- Treat other members and staff with respect.

6. Prohibited Conduct (Immediate or Permanent Ban)

Self-promotion or advertising of any other Discord servers, services, bookies, social media accounts, or similar — including in DMs. This results in an immediate ban.

Sharing or linking viruses, malware, IP grabbers, harmful content, or anything illegal — permanent ban.

Harassment, spam, toxicity, or behavior that harms the community.

Copying, redistributing, reselling, or commercially using our content, picks, or strategies without written permission.

7. No Liability & Indemnification

To the fullest extent permitted by law, Boost World, its owner/operator, moderators, and affiliates are not liable for any direct, indirect, incidental, consequential, special, or other damages or losses arising from:

- Your use of the Discord or any content
- Following any bets, strategies, or information shared
- Your sports betting activity or financial decisions
- Technical issues, downtime, or missed notifications

You agree to indemnify, defend, and hold harmless Boost World and its operators from any claims, losses, damages, or expenses (including reasonable attorneys' fees) arising from your use of the service, your betting activity, or your violation of these Terms.

12. Refund & Satisfaction Policy

Yearly Subscriptions: Yearly plans are paid in full upfront for the entire year. We do not offer prorated refunds if you decide to cancel early.

General Rules: In all cases, please contact us directly in Discord first before initiating any chargeback or dispute through Whop or your payment provider. Members who work with us directly are almost always taken care of quickly and fairly. Abuse of this policy or repeated refund requests may result in removal from the community.

We reserve the right to suspend or permanently remove any member at any time, for any reason, including violation of these Terms or conduct we determine is harmful to the community, at our sole discretion. No refunds are issued for terminations due to violations, except as provided in our Refund & Satisfaction Policy.
