

End User License Agreement

This End User License Agreement ("EULA") is a contract between you and PortLab for the digital materials you purchase, including guides, videos, device tree templates, checklists, kernel notes, and any updates we provide.

By completing checkout or downloading files, you agree to this EULA, the Terms of Service, Privacy Policy, and Refund Policy.

1. License grant

PortLab grants you a personal, limited, non-exclusive, non-transferable, revocable license to:

- Download and store the materials for your own use
- Use templates and checklists to port ColorOS onto devices you own or are authorized to modify
- Keep access for as long as your Whop membership for that product remains valid

If a product page says transfers are allowed, you may transfer only through Whop's transfer flow. Otherwise, the license is for you alone.

2. What you may not do

Except as allowed by mandatory law, you may not:

- Share, sell, rent, sublicense, or publicly upload paid PortLab files or videos
- Post the full guide, or substantial copies of it, on forums, Telegram, GitHub, or file hosts
- Use PortLab materials to build a competing paid course or paid porting kit
- Remove copyright, trademark, or attribution notices
- Record private support sessions for public distribution

You may keep private notes and you may keep a finished port on your own device. Publishing your own original tree is your responsibility and must not include PortLab's paid commentary copied wholesale.

3. Ownership

PortLab retains all rights in its original writing, videos, diagrams, branding, and original template structure. This EULA does not assign copyright to you.

Third-party firmware, vendor blobs, kernel sources, and trademarks belong to their owners. PortLab does not license those to you. You must obtain firmware and sources from lawful channels and follow their licenses.

4. Templates and sample trees

Device tree templates are starting points. You must adapt them to your device. They are not a guaranteed drop-in for every Xiaomi, Poco, or Redmi board. You assume the risk of using them.

5. Updates

If your product includes lifetime guide updates, PortLab may add or replace files in the same product. Updates are licensed under this EULA. We are not required to support every new ColorOS version on the day it ships.

6. Support access

Chat or support included with a plan is a service, not a second copyright license. When the stated support window ends, the license to the files continues if your product page says you keep the guide, but the chat access ends.

7. Termination

This license ends if you materially breach it or the Terms of Service, or if your purchase is refunded or charged back. On termination you must delete PortLab files still in your possession, except copies the law requires you to keep. We may also remove Whop access.
