

Terms of Service

1. Agreement

These Terms of Service ("Terms") govern your purchase and use of the Jack Adams Private Team products and community. You accept these Terms when you complete checkout on Whop or use our services. Our Returns & Refund Policy, Privacy Policy, and End User License Agreement form part of these Terms.

2. Eligibility

You must be at least 18 years old and legally capable of entering binding contracts in your jurisdiction.

3. Services Provided

We provide access to a private Discord community; digital trading education and materials, including The Advanced Trading Course; market analysis, trade ideas, and discussion; and research/screening software ("scanners"). We may modify, add, or remove features at any time; where a change materially reduces a paid service, we will give reasonable notice.

4. Education Only - No Financial Advice

Everything we publish is general education, analysis, and commentary. It is not financial, investment, tax, or legal advice, is not a personal recommendation, and does not take your circumstances into account. We are not authorised or regulated by the Financial Conduct Authority and do not provide regulated investment services. Trading and investing carry a high level of risk: you can lose some or all of your capital, and past performance is not a reliable indicator of future results. You are solely responsible for your own decisions.

5. Memberships and Billing

Full Team is a recurring subscription: \$120 renewing monthly or \$300 renewing every 3 months, until cancelled via your Whop account. The billing interval is displayed at checkout before payment and in Whop renewal emails. Cancellation takes effect at the end of the paid period. One-time products (such as the course) are single purchases. Legacy lifetime memberships remain valid for existing holders but are no longer sold. If we change subscription pricing, the new price applies only from your next renewal after at least 14 days notice. Failed renewal payments may result in suspension of access until payment succeeds. Refunds are governed by the Returns & Refund Policy.

6. Intellectual Property

All content - courses, written materials, trade ideas, strategies, scanners, designs, and branding - is our intellectual property, licensed to you under the EULA. You may not reproduce, distribute, resell, or share access without express written consent. Violation may result in termination and legal action.

7. Prohibited Conduct

You agree not to: share your account or distribute content outside the community; harass, threaten, or abuse other members; use the community to promote scams, fraud, or illegal activity; or attempt to

undermine, disrupt, scrape, or copy our services. Violation may result in immediate termination without refund of amounts already paid for the current period.

8. Termination

We may suspend or terminate your access if you violate these Terms, engage in fraudulent payment activity (including unfounded chargebacks), or breach our intellectual property rights. On termination for breach, no refund is due for the current billing period. You may end your membership at any time by cancelling in Whop.

9. Disclaimers and Limitation of Liability

Our services are provided on an "as is" and "as available" basis. We make no guarantees regarding financial outcomes, trading performance, or profits. To the fullest extent permitted by law, we exclude liability for trading or investment losses arising from your use of our services, and our total liability to you is limited to the amounts you paid us in the 12 months before the claim arose.

Nothing in these Terms excludes or limits our liability for death or personal injury caused by our negligence, for fraud or fraudulent misrepresentation, or for any liability that cannot be excluded by law. If you are a consumer, nothing in these Terms affects your statutory rights.

10. Indemnification

You agree to indemnify and hold harmless Jack Adams Private Team, its owner, and affiliates from claims, damages, or expenses (including reasonable legal fees) arising from your breach of these Terms or unlawful use of our services. This clause does not apply to liabilities caused by our own breach or negligence.

11. Governing Law and Disputes

These Terms are governed by the laws of England and Wales, and disputes are subject to the jurisdiction of the courts of England and Wales. If you are a consumer resident elsewhere in the UK or EU, you also benefit from any mandatory protections of, and may bring proceedings in, your country of residence. Before any formal dispute, you agree to contact us first and to use the Whop Resolution Center in good faith.

12. Changes to These Terms

We may update these Terms. Material changes will be posted on Whop with an updated "Last Updated" date, and material changes affecting subscriptions will apply from your next renewal. Continued use after changes take effect constitutes acceptance.

13. General

If any provision of these Terms is found unenforceable, the remainder continues in effect. A failure to enforce any provision is not a waiver. You may not assign these Terms; we may assign them to a successor of the business. These Terms, together with the documents referenced in Section 1, are the entire agreement between us.
