

Refund and Cancellation Policy

Elliott Wave Club LLC, doing business as Elliott Wave Club | Last updated: May 4, 2026

This Refund and Cancellation Policy applies to purchases of Elliott Wave Club Elite and related digital membership products offered by the company identified above. In this policy, references to Elliott Wave Club, we, us, and our refer to that company and brand.

By purchasing, subscribing to, or accessing our digital membership, you acknowledge and agree to this policy, in addition to Whop's applicable terms and any platform policies that apply to your purchase.

1. Digital Membership Access

Elliott Wave Club Elite is a digital subscription membership that provides access to educational market analysis, trade plans, Discord channels, community content, and related trading education resources. Access is generally provided immediately after purchase or shortly after the platform completes membership activation.

2. Recurring Subscription Billing

- Removal, suspension, or termination for violating community rules, our Terms of Service, Whop terms, or any applicable platform terms.
- Purchases made by household members, minors, dependents, or other persons who had access to your device, account, payment credentials, or payment method, unless required otherwise by applicable law or platform policy.
- Requests made after digital membership access, Discord access, paid channels, alerts, trade plans, or other paid materials were made available.

Refunds may be considered only in limited cases, such as:

- Duplicate charges caused by a technical or billing error.
- Technical access issues that prevent access to the purchased membership and cannot reasonably be resolved.
- Situations where a refund is required by applicable law, payment network rules, or Whop policy.
- Other exceptions approved at the sole discretion of Elliott Wave Club LLC and/or Whop.

Submitting a refund request does not guarantee approval. We may request additional information, including access logs, payment records, Discord activity, communications, or other evidence relevant to the request.
