

TERMS OF SERVICE — THE TRADING SHELTER

Operated by LES ENTREPRISES RODGLOBAL INC. / RODGLOBAL ENTERPRISES INC.

1. Acceptance of These Terms

These Terms of Service form a binding agreement between you and LES ENTREPRISES RODGLOBAL INC. / RODGLOBAL ENTERPRISES INC., governing your purchase of and access to The Trading Shelter, including all content, courses, live sessions, community channels, and optional one-on-one coaching services.

By purchasing a membership through Whop, joining our Discord server, or otherwise accessing The Trading Shelter, you confirm that you have read, understood, and agree to be bound by these Terms of Service. If you do not agree, do not purchase a membership or access The Trading Shelter.

2. Eligibility

- You must be at least **18 years of age** to purchase a membership or access The Trading Shelter.
- You must have the legal capacity to enter into a binding contract.
- You are responsible for ensuring that your use of The Trading Shelter is lawful where you reside. We make no representation that our services are appropriate or available in any particular location.
- You must comply at all times with the Terms of Service of Discord Inc. and Whop Inc.

3. Description of the Services

The Trading Shelter is a **paid, private, educational community** hosted on Discord and sold through Whop. It may include:

- Educational lessons, courses, and recorded content related to trading and financial markets;
- Community discussion channels, market commentary, and shared analysis;
- Live sessions, reviews, and Q&A;
- **Optional one-on-one coaching sessions**, sold separately as an add-on.

Everything we provide is for **educational and informational purposes only**. We do not provide trade signals, portfolio management, brokerage services, or personalized investment recommendations.

4. Not Financial Advice — Educational Disclaimer

READ THIS SECTION CAREFULLY. IT IS A FUNDAMENTAL CONDITION OF YOUR MEMBERSHIP.

4.1. No licensed status. We, our owners, moderators, coaches, and contributors are **not licensed or registered financial advisors, broker-dealers, portfolio managers, or investment counsellors**. Nothing in The Trading Shelter constitutes financial, investment, legal, tax, or accounting advice.

4.2. Educational purpose only. All content — including lessons, strategies, chart analysis, live sessions, market commentary, one-on-one coaching, and member discussions — reflects **personal experience and opinion** and is provided strictly for educational purposes. It is general in nature and does not take into account your personal financial situation, objectives, or risk tolerance.

4.3. No advisory or fiduciary relationship. Your membership, including any one-on-one coaching session, does **not** create an advisor-client, fiduciary, or professional relationship of any kind. Coaching sessions are educational discussions, not personalized investment recommendations.

4.4. Independent decisions. Any trading or investment decision you make is made solely by you, at your own risk, based on your own judgment. You should conduct your own research and consult a **licensed financial advisor** before making any financial decision.

4.5. **No performance guarantees.** We make no representation or guarantee that you will achieve any particular result, profit, or income. Past performance — whether ours, a coach's, or another member's — is **not indicative of future results**. Any examples, screenshots, or testimonials represent individual experiences and are **not typical**; most traders lose money.

5. Risk Disclosure

Trading financial instruments — including but not limited to stocks, options, futures, forex, contracts for difference (CFDs), and cryptocurrencies — involves **substantial risk of loss** and is not suitable for every person. Leverage can amplify losses beyond your initial deposit. You may lose some or all of your invested capital. **Never trade with money you cannot afford to lose.** By using The Trading Shelter, you acknowledge and accept these risks in full and agree that we bear no responsibility for any trading or investment losses you incur.

6. Membership, Billing & Auto-Renewal

6.1. **Payment processor.** All memberships and coaching sessions are sold and billed exclusively through **Whop**. Your payment is also subject to Whop's own Terms of Service and privacy policy. We do not collect or store your payment card details.

6.2. **Subscriptions and auto-renewal.** Unless stated otherwise at checkout, memberships are recurring subscriptions that **renew automatically** at the end of each billing period at the then-current price, until cancelled. By subscribing, you authorize recurring charges to your payment method via Whop.

6.3. **Cancellation.** You may cancel your subscription at any time through your Whop account dashboard. Cancellation takes effect at the **end of the current billing period**; you retain access until that date. Cancellation stops future charges but does not entitle you to a refund of amounts already paid.

6.4. **Price changes.** We may change membership pricing at any time. Price changes apply to **new billing periods only** and will be communicated with reasonable advance notice before they affect an active subscription.

6.5. **Taxes.** Prices may be exclusive of applicable taxes (such as sales tax or VAT), which may be added at checkout depending on your location.

6.6. **Failed payments.** If a renewal payment fails, access to The Trading Shelter may be suspended or terminated until payment is completed.

7. Refund Policy — All Sales Final

7.1. **All sales are final.** Given the digital nature of our services and the immediate access to proprietary content upon purchase, **we do not offer refunds**, except as described in Section 7.2 or where required by applicable law.

7.2. **Wrong-tier exception.** If you mistakenly purchase the incorrect membership tier, you must contact us within **three (3) business days** of the transaction at support@thetradingshelter.com. In that case, we will adjust your subscription to the correct tier (with a corresponding charge or credit for the price difference). After this three-day window, no changes, credits, or refunds will be issued.

7.3. **Immediate access waiver.** By purchasing, you expressly request and consent to **immediate access** to digital content upon payment, and — to the extent permitted by applicable law — you acknowledge that you thereby **waive any statutory right of withdrawal or "cooling-off" period** applicable to digital content once access has been delivered.

7.4. **Coaching sessions.** One-on-one coaching purchases are final. Sessions must be scheduled and used within **ninety (90) days** of purchase unless otherwise agreed in writing. You may reschedule a session with at least **24 hours' notice**. Missed sessions or cancellations with less than 24 hours' notice are forfeited without refund.

7.5. **Chargebacks.** Initiating a chargeback or payment dispute in bad faith — without first contacting us to resolve the issue — constitutes a material breach of these Terms of Service and will result in **immediate and permanent termination** of your membership and ban from the community. We reserve the right to contest fraudulent chargebacks and to recover associated costs.

7.6. **Statutory rights.** Nothing in this Section limits any non-waivable rights you may have under mandatory consumer protection laws applicable to you.

8. Accounts & Access

8.1. Access to The Trading Shelter requires a valid Discord account linked to your Whop purchase. You are responsible for the security of your accounts.

8.2. **One membership = one person.** Memberships are personal and non-transferable. **Account sharing, credential sharing, or reselling access is strictly prohibited** and grounds for immediate termination without refund.

8.3. We may modify, add, remove, or restructure channels, content, features, or coaching availability at any time as part of the normal operation and improvement of our services.

9. Intellectual Property

9.1. **Ownership.** All content provided through The Trading Shelter — including lessons, courses, videos, documents, frameworks, strategies, templates, analysis, branding, and the "The Trading Shelter" name and logo — is our exclusive property or that of our licensors and is protected by applicable copyright, trademark, and intellectual property laws.

9.2. **Limited license.** Your membership grants you a **limited, personal, non-exclusive, non-transferable, revocable license** to access and use the content for your own private, non-commercial education, for the duration of your active membership. This license terminates automatically when your membership ends or is terminated.

9.3. **Prohibited uses.** You may not, without our prior written consent:

- Copy, record, screenshot, download, scrape, or otherwise reproduce content for distribution;
- Share, leak, publish, resell, or redistribute any content inside or outside the community;
- Use the content to build, market, or operate a competing product, community, or course;
- Remove or alter any proprietary notices.

9.4. **Enforcement.** Unauthorized reproduction or distribution of our content constitutes copyright infringement and breach of contract, and will result in immediate termination without refund and may result in **legal action for damages and injunctive relief**.

10. Confidentiality

All strategies, analysis, materials, and discussions shared within The Trading Shelter are confidential. You agree to keep such information within the community and not to disclose, publish, or share it with non-members. This obligation survives the termination of your membership.

11. Community Rules & Code of Conduct

To maintain a professional and respectful environment, all members must comply with the following rules:

- 1 **No prohibited topics.** No discussions or content related to politics, religion, racism, sexism, or sexually explicit material.
- 2 **Respect.** Harassment, discrimination, hate speech, threats, or personal attacks will not be tolerated.
- 3 **Channel discipline.** Use the appropriate channels for each topic; keep off-topic discussion in designated areas.

- 4 **No spam or self-promotion.** No advertising, solicitation, referral links, or self-promotion without prior written approval from the admin team.
- 5 **No unlicensed advice.** Members must not present themselves as licensed professionals or provide personalized investment advice to other members.
- 6 **No market abuse.** Any form of market manipulation, pump-and-dump coordination, sharing of material non-public (insider) information, or unethical or unlawful trading practices is strictly prohibited.
- 7 **Respect intellectual property.** Do not share content — ours or third parties' — that you do not have the right to distribute.
- 8 **No impersonation.** Do not impersonate staff, moderators, coaches, or other members.
- 9 **No malicious activity.** No phishing, scamming, doxxing, malware, or attempts to exploit or disrupt the community, Discord, or Whop.

Moderators have full discretion to enforce these rules, including deleting content, muting, suspending, or removing members. **Violation of these rules may result in immediate removal from the community without refund.**

12. Member Content

If you post messages, charts, analysis, or other content in the community, you retain ownership of it, but you grant us a worldwide, royalty-free, non-exclusive license to host, display, and reproduce it within the community and, in anonymized form, for educational or promotional purposes. You are solely responsible for the content you post and represent that it does not infringe any third-party rights or applicable law. We may remove any member content at our discretion.

13. Third-Party Platforms & Services

The Trading Shelter depends on third-party platforms, including **Discord** (hosting) and **Whop** (payments and access management), and may reference third-party tools, brokers, exchanges, or data providers. We do not control and are not responsible for these third parties, their availability, their terms, or any losses arising from your use of them. Outages, feature changes, or account actions taken by Discord or Whop are outside our control and do not entitle you to a refund.

14. Suspension & Termination

14.1. **By you.** You may terminate by cancelling your subscription via Whop (see Section 6.3).

14.2. **By us.** We may suspend or terminate your membership immediately, without refund, if you: (a) breach these Terms of Service or the community rules; (b) engage in fraud, chargebacks in bad faith, or unlawful conduct; (c) share, leak, or redistribute content; or (d) behave in a manner harmful to the community, its members, or our business.

14.3. **Effect of termination.** Upon termination, your license to access all content ends immediately. Sections 4, 5, 7, 9, 10, 12, and 15 through 19 survive termination.

15. Disclaimer of Warranties

THE TRADING SHELTER AND ALL RELATED SERVICES ARE PROVIDED "**AS IS**" AND "**AS AVAILABLE**," WITHOUT WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, ACCURACY, COMPLETENESS, OR NON-INFRINGEMENT. WE DO NOT WARRANT THAT THE SERVICES WILL BE UNINTERRUPTED, ERROR-FREE, OR THAT ANY CONTENT IS ACCURATE, CURRENT, OR RELIABLE. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF CERTAIN WARRANTIES; IN SUCH CASES, THE ABOVE EXCLUSIONS APPLY TO THE MAXIMUM EXTENT PERMITTED BY LAW.

16. Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW:

(a) WE AND OUR DIRECTORS, OFFICERS, EMPLOYEES, COACHES, MODERATORS, AND CONTRIBUTORS SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, EXEMPLARY, OR PUNITIVE DAMAGES, OR FOR ANY **TRADING OR INVESTMENT LOSSES, LOST PROFITS, LOST OPPORTUNITIES, OR LOSS OF DATA**, ARISING FROM OR RELATED TO THE SERVICES, EVEN IF ADVISED OF THE POSSIBILITY OF SUCH DAMAGES;

(b) OUR TOTAL AGGREGATE LIABILITY FOR ANY CLAIM ARISING OUT OF OR RELATING TO THESE TERMS OF SERVICE OR THE SERVICES SHALL NOT EXCEED THE **TOTAL AMOUNT OF MEMBERSHIP FEES YOU PAID TO US IN THE TWELVE (12) MONTHS PRECEDING THE EVENT GIVING RISE TO THE CLAIM**.

Nothing in these Terms of Service excludes liability that cannot be excluded under applicable law, including liability for fraud or for death or personal injury caused by negligence.

17. Indemnification

You agree to indemnify, defend, and hold harmless LES ENTREPRISES RODGLOBAL INC. / RODGLOBAL ENTERPRISES INC. and its directors, officers, employees, coaches, and moderators from and against any claims, damages, losses, liabilities, costs, and expenses (including reasonable legal fees) arising from: (a) your use of The Trading Shelter; (b) your trading or investment activity; (c) content you post; (d) your breach of these Terms of Service; or (e) your violation of any law or third-party right.

18. Changes to These Terms

We may update these Terms of Service at any time. The updated version will be posted within the community and/or on Whop, and we will notify members of material changes. Continued use of The Trading Shelter after changes take effect constitutes acceptance of the updated Terms of Service. If you do not agree, your sole remedy is to cancel your membership.

19. Governing Law & Dispute Resolution

19.1. **Governing law.** These Terms of Service are governed by the laws of the jurisdiction in which LES ENTREPRISES RODGLOBAL INC. / RODGLOBAL ENTERPRISES INC. is incorporated, without regard to conflict-of-law principles.

19.2. **Informal resolution first.** Before initiating any formal proceeding, you agree to contact us at support@thetradingshelter.com and attempt in good faith to resolve the dispute informally within thirty (30) days.

19.3. **Venue.** Subject to any non-waivable consumer rights applicable to you, any dispute that cannot be resolved informally shall be submitted to the exclusive jurisdiction of the competent courts of the place where LES ENTREPRISES RODGLOBAL INC. / RODGLOBAL ENTERPRISES INC. has its registered office.

19.4. **No class actions.** To the maximum extent permitted by applicable law, disputes shall be brought on an individual basis only, and not as a plaintiff or class member in any purported class or representative proceeding.

20. General Provisions

- **Entire agreement.** These Terms of Service, together with any policies referenced herein and the applicable Whop checkout terms, constitute the entire agreement between you and us regarding The Trading Shelter.
- **Severability.** If any provision is held invalid or unenforceable, the remaining provisions remain in full force and effect.
- **No waiver.** Our failure to enforce any provision is not a waiver of our right to enforce it later.

- **Assignment.** You may not assign or transfer your rights under these Terms of Service. We may assign them in connection with a merger, acquisition, or sale of assets.
- **Force majeure.** We are not liable for delays or failures caused by events beyond our reasonable control, including outages of Discord, Whop, or internet infrastructure.
- **Language.** These Terms of Service are drafted in English. Where a translation is provided, the English version prevails to the extent permitted by applicable law.
