

END USER LICENSE AGREEMENT (EULA) — THE TRADING SHELTER

Operated by LES ENTREPRISES RODGLOBAL INC. / RODGLOBAL ENTERPRISES INC.

1. About This Agreement

This End User License Agreement is a binding agreement between you and LES ENTREPRISES RODGLOBAL INC. / RODGLOBAL ENTERPRISES INC. It governs your right to access and use the digital content and materials made available through The Trading Shelter, including via Whop, Discord, and Zoom.

By purchasing a membership or coaching session, accessing the community, or viewing any of our content, you accept this Agreement. If you do not accept it, do not purchase, access, or use The Trading Shelter. This Agreement operates alongside our Terms of Service, Privacy Policy, and Return & Refund Policy.

2. Licensed Materials

This Agreement covers all content and materials made available through The Trading Shelter, including:

- Lessons, courses, videos, and recorded educational content;
- Live session recordings and one-on-one coaching session recordings, including those delivered via Zoom links;
- Documents, frameworks, templates, checklists, and written strategies;
- Chart analysis, market commentary, and educational posts published by us in the community;
- The "The Trading Shelter" name, logo, branding, and the structure, organization, and presentation of the community itself.

All of the above are referred to in this Agreement as the licensed materials.

3. License Grant

3.1. Subject to your active, paid membership and your compliance with this Agreement and our Terms of Service, we grant you a **limited, personal, non-exclusive, non-transferable, non-sublicensable, revocable license** to access, view, and use the licensed materials.

3.2. This license is granted **solely for your own private, non-commercial education**.

3.3. For one-on-one coaching recordings, the license extends only to the member who purchased the session, for personal review purposes.

3.4. This is a **license, not a sale**. You acquire no ownership interest in any licensed materials, regardless of how long you remain a member or how much you have paid.

4. License Restrictions

You may not, and may not permit or assist anyone else to:

- 1 **Copy or capture** — download, copy, screenshot, screen-record, transcribe, scrape, or otherwise reproduce the licensed materials, except where a download function is expressly provided by us;
- 2 **Distribute** — share, publish, post, forward, stream, or otherwise make the licensed materials available to any non-member, on any platform, channel, group, or website, whether free or paid;
- 3 **Share access** — share your Discord or Whop account, membership seat, or any Zoom recording link with any other person;
- 4 **Resell** — sell, rent, lease, sublicense, or otherwise commercialize the licensed materials or access to them;

- 5 **Create derivatives** — modify, adapt, translate, or create derivative works from the licensed materials, including repackaging them into your own course, community, ebook, or content product;
- 6 **Compete** — use the licensed materials to build, train, market, or operate a competing product, community, course, or service, including using them as training data for any software or artificial intelligence system;
- 7 **Strip protections** — remove, obscure, or alter any copyright, trademark, watermark, or other proprietary notices;
- 8 **Misattribute** — present the licensed materials, in whole or in part, as your own work.

5. Ownership & Reservation of Rights

All right, title, and interest in and to the licensed materials — including all copyright, trademark, and other intellectual property rights — belong exclusively to LES ENTREPRISES RODGLOBAL INC. / RODGLOBAL ENTERPRISES INC. or its licensors. All rights not expressly granted in Section 3 are reserved. Nothing in this Agreement transfers any intellectual property rights to you.

6. Content You Post

Content you post within the community remains yours, subject to the license you grant us under our Terms of Service. Posting content in the community does not give any other member a license to reproduce or distribute your content outside the community.

7. Confidentiality of Materials

The licensed materials, including strategies, frameworks, session recordings, and internal community discussions, are confidential. You agree to keep them within the community and not to disclose them to any non-member. This obligation survives the end of your membership.

8. Term, Suspension & Termination

8.1. **Term.** Your license begins when you first gain access and continues only while your membership is active and paid.

8.2. **Automatic termination.** Your license terminates automatically and immediately when: (a) your membership is cancelled, expires, or lapses due to non-payment; (b) your membership is terminated for breach of this Agreement or our Terms of Service; or (c) The Trading Shelter is discontinued.

8.3. **Effect of termination.** Upon termination, you must cease all access to and use of the licensed materials and delete any copies in your possession, however obtained. Sections 4, 5, 7, 9, 10, 11, and 12 survive termination.

8.4. **No refund on termination for breach.** Termination of your license for breach does not entitle you to any refund, as set out in our Return & Refund Policy.

9. Educational Content Only — No Advice

The licensed materials are provided **strictly for educational and informational purposes**. They do not constitute financial, investment, legal, tax, or accounting advice, and no advisory or fiduciary relationship is created by this Agreement or by your use of the licensed materials. Trading involves substantial risk of loss. The full educational disclaimer and risk disclosure in our Terms of Service apply to all licensed materials and are incorporated into this Agreement by reference.

10. No Warranties

THE LICENSED MATERIALS ARE PROVIDED "**AS IS**" AND "**AS AVAILABLE**," WITHOUT WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, ACCURACY, COMPLETENESS, OR NON-INFRINGEMENT. WE DO NOT WARRANT THAT THE LICENSED MATERIALS WILL BE AVAILABLE WITHOUT INTERRUPTION, ERROR-FREE, OR CONTINUOUSLY MAINTAINED IN ANY PARTICULAR FORM. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF CERTAIN WARRANTIES; IN SUCH CASES, THE ABOVE EXCLUSIONS APPLY TO THE MAXIMUM EXTENT PERMITTED BY LAW.

11. Limitation of Liability

TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, OUR TOTAL AGGREGATE LIABILITY ARISING OUT OF OR RELATING TO THIS AGREEMENT OR THE LICENSED MATERIALS SHALL NOT EXCEED THE TOTAL AMOUNT OF MEMBERSHIP FEES YOU PAID TO US IN THE TWELVE (12) MONTHS PRECEDING THE EVENT GIVING RISE TO THE CLAIM, AND WE SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, EXEMPLARY, OR PUNITIVE DAMAGES, OR FOR ANY TRADING OR INVESTMENT LOSSES, LOST PROFITS, OR LOST OPPORTUNITIES. NOTHING IN THIS AGREEMENT EXCLUDES LIABILITY THAT CANNOT BE EXCLUDED UNDER APPLICABLE LAW.

12. Enforcement & Remedies

12.1. You acknowledge that unauthorized copying, sharing, or distribution of the licensed materials would cause us irreparable harm for which monetary damages alone would be inadequate. In addition to any other remedies available, we are entitled to seek **injunctive relief** to prevent or stop any breach of Sections 4 or 7.

12.2. Breach of this Agreement results in **immediate termination of your membership without refund** and may result in legal action for damages, disgorgement of any revenue derived from our materials, and recovery of enforcement costs to the extent permitted by law.

12.3. We may use technical measures — including watermarking and access logs — to identify the source of leaked materials.

13. Changes to the Licensed Materials & This Agreement

We may add, modify, restructure, or remove licensed materials at any time as part of the normal operation and improvement of The Trading Shelter; this does not entitle you to a refund. We may also update this Agreement at any time; the updated version will be posted within the community and/or on Whop, and continued use after changes take effect constitutes acceptance.

14. Relationship to Other Documents

This Agreement forms part of a single contractual framework together with our Terms of Service, Privacy Policy, and Return & Refund Policy. In the event of a direct conflict regarding the licensing or use of content, this Agreement prevails; for all other matters, the Terms of Service prevail.

15. General Provisions

- **Governing framework.** This Agreement is governed by the laws of the jurisdiction in which LES ENTREPRISES RODGLOBAL INC. / RODGLOBAL ENTERPRISES INC. is incorporated, and any dispute is subject to the dispute resolution provisions of our Terms of Service.
- **Severability.** If any provision is held invalid or unenforceable, the remaining provisions remain in full force and effect.
- **No waiver.** Our failure to enforce any provision is not a waiver of our right to enforce it later.

- **Assignment.** You may not assign this Agreement. We may assign it in connection with a merger, acquisition, or sale of assets.
- **Entire agreement.** This Agreement, together with the documents referenced in Section 14, constitutes the entire agreement regarding your license to the licensed materials.
