

VintedSeekers – Terms of Service

These Terms of Service (“Terms”) govern the purchase and use of the digital product “VintedSeekers”, delivered through a private Discord server. By purchasing, accessing, or using VintedSeekers you agree to be bound by these Terms.

1. Service Description

VintedSeekers is a digital monitoring and information service that provides notifications, data monitoring, or marketplace insights related to listings on the Vinted platform. The service is delivered digitally via Discord and related tools. No physical product is provided.

2. Independent Service

VintedSeekers is an independent service and is not affiliated with, endorsed by, or connected to Vinted or Discord. All trademarks, brands, and platforms belong to their respective owners.

3. Access Requirements

- Users must maintain an active Discord account.
- Users must comply with all rules of the VintedSeekers Discord server.
- Users must comply with the terms and policies of third-party platforms including Vinted and Discord.
- Access may be suspended or revoked if a user violates these Terms or community rules.

4. Marketplace & Platform Risk Disclaimer

VintedSeekers relies on data, listings, or marketplace activity from third-party platforms such as Vinted. These platforms may change their APIs, policies, access permissions, or technical systems at any time. Such changes may affect the availability, speed, or functionality of the service. These external changes are outside our control and do not constitute service failure.

5. User Account Responsibility

Users are solely responsible for their own marketplace accounts including Vinted accounts. We do not access, control, or manage user accounts. Any suspension, limitation, or ban applied by Vinted or other platforms is the responsibility of the user and is not caused by VintedSeekers.

6. Risk of Account Restrictions

Marketplace platforms may impose restrictions, suspensions, or permanent bans for a variety of reasons including automated detection systems, platform policies, or user behavior. By using VintedSeekers, users acknowledge and accept that such actions may occur and that VintedSeekers bears no responsibility for platform enforcement decisions.

7. License to Use the Service

Purchasing VintedSeekers grants a limited, non-transferable, non-exclusive license to access and use the service for personal use only. Redistribution, resale, sharing of access, or reproduction of the service

or its data is strictly prohibited.

8. No Profit Guarantee

9. Chargebacks & Payment Disputes

Users agree to contact support before initiating a chargeback or payment dispute. Filing a chargeback without attempting resolution may result in immediate suspension or permanent termination of access. We reserve the right to provide evidence of service delivery, access logs, Discord server membership, and agreement to these Terms to payment processors to dispute fraudulent chargebacks.

10. Limitation of Liability

To the maximum extent permitted under applicable EU law, VintedSeekers shall not be liable for indirect, incidental, consequential, or economic losses resulting from use of the service, marketplace activity, platform bans, or external platform changes.

11. Service Availability
