

Terms of Service

Print Squad · All Products and Services · Effective June 15, 2026 · Last Updated June 15, 2026

These Terms of Service (the “Terms”) govern your access to, purchase of, and use of all Print Squad products and services, including the Print Squad community and Discord server, memberships and subscriptions, pre-market game plans, trade alerts, mentorship, and all indicators, scripts, tools, templates, and other digital products (collectively, the “Products and Services”), operated by Print Squad (“Print Squad,” “we,” “us,” or “our”) through fnptrades.com and its authorized platforms. By accessing, joining, purchasing, downloading, or using any Print Squad Product or Service, you (“you” or “user”) agree to be bound by these Terms. If you do not agree, do not access, purchase, or use the Products and Services.

By purchasing or using any Print Squad product or service, you agree to the following:

1. All Print Squad products, services, and content are educational reference tools only and do not constitute financial advice.
2. No specific trading results or profits are guaranteed.
3. You are solely responsible for all trading decisions and their outcomes.
4. All sales are final — refund requests based on user error, lack of engagement, or unmet profit expectations will be denied.
5. Digital access is delivered immediately upon purchase, which constitutes delivery of the product.

1. Scope and Acceptance

Trade alerts, pre-market game plans, and live commentary reflect the personal opinions and activity of Print Squad and its contributors at a given moment and are shared for educational purposes only. They are not instructions or recommendations for you to enter, exit, or manage any position. Real-time content may be delayed, incomplete, or unavailable, and you should never act on any alert or idea without conducting your own independent analysis.

9. Indicators and Digital Products — License and Permitted Use

Subject to these Terms, Print Squad grants you a limited, personal, non-exclusive, non-transferable, revocable license to use any indicator, script, tool, or digital product you purchase or access for your own personal, non-commercial trading and education. You may not: (a) copy, share, resell, sublicense, lease, or redistribute any Product, its code, or your access; (b) decompile, reverse-engineer, republish, or create derivative works from a Product except as expressly permitted; or (c) share access credentials or invite-only access with any third party. Unauthorized distribution voids your license without refund and may result in revocation of access and legal action.

10. Intellectual Property

All Products, Services, content, materials, indicators, underlying code, logic, design, names, and branding are the exclusive property of Print Squad or its licensors and are protected by applicable intellectual property laws. Your membership or purchase grants you only the limited, personal, non-transferable, revocable license described in these Terms; no ownership rights are transferred to you. 11. Payments, Billing, and Immediate Digital Delivery

This is a correction of delivery or billing — not a profit-based or satisfaction-based refund.

Chargebacks. Initiating a chargeback or payment dispute in violation of these Terms may result in immediate and permanent termination of your access to all Print Squad Products, Services, and Communities. We

reserve the right to contest such disputes with documentation of delivery and of your acceptance of these Terms.

Subscriptions. For recurring subscriptions, you may cancel at any time to stop future billing. Cancellation ends renewal going forward and does not retroactively refund amounts already paid for the current or prior billing periods. You will retain access through the end of your paid period.
