This may include:

- IP address
- Cookies and similar technologies

We use this information to:

- Improve our website
- Analyze website traffic
- Understand customer behavior

- Prevent fraud and abuse

IP addresses may be stored for security, fraud prevention, and dispute resolution purposes.

Cookies and Analytics

Our website may use cookies, pixels, analytics tools, and similar technologies to improve user experience and measure website performance.

These technologies may include services such as:

- Other analytics or advertising platforms

You may disable cookies through your browser settings, although certain features of our website may not function properly.
