

Terms & Conditions

Effective date: August 9, 2026

These Terms & Conditions (the “Terms”) govern your purchase of and access to the programs, memberships, communities, courses, boot camps, and other digital products and services offered by Becoming Pretty Profitable (“BPP,” “we,” “us,” or “our”) (each, a “Product”). By completing checkout and checking the box to accept these Terms, you agree to be bound by them. If you do not agree, do not purchase or access the Product.

1. What you are purchasing
