Refund Policy

Overview

Aval Trades ("we," "us," "our") operates The Consistent Trader Combine, a 3-day live trading education event delivered via Zoom on June 29, June 30, and July 1, 2026 at 7:00 PM EST.

This Refund Policy applies to all ticket purchases for The Consistent Trader Combine, including General Admission (\$47) and VIP Access (\$97) tickets.

Our Guarantee



The Show-Up-And-Do-The-Work Guarantee

Show up for all 3 days. Do the work. If you go through the entire combine and don't walk away with a clear, executable trading framework you can run every week, we will refund every dollar.

No hoops. No hassle. Just email us within 7 days of Day 3 and you are covered.

The only way you lose is if you don't show up.

Refund Eligibility

To qualify for a refund under our guarantee, you must meet **every single one** of the following conditions. Failure to meet even one disqualifies the request.

Full Attendance: You must be present and logged into the Zoom session from start to finish for all three nights (June 29, June 30, and July 1). "Present" means your camera or Zoom account is active for the entire duration of each session. Joining late, leaving early, or missing any portion of any session disqualifies eligibility.

On-Time Arrival: You must join each live session at or before the scheduled 7:00 PM EST start time. Late arrivals are not considered full attendance.

Pre-Combine Preparation: You must complete all pre-combine assignments, preparation materials, and action items sent prior to Day 1, including watching any required videos, joining the Telegram group, and completing any pre-event exercises distributed before the combine begins.

Active Participation: You must actively participate during all live sessions, including completing all in-session exercises, worksheets, action items, and assignments given during each night of the combine. Passive viewing without completing the work does not qualify.

VIP Requirements (VIP ticket holders only): VIP ticket holders must also attend all VIP breakout sessions in full to maintain refund eligibility.

Refund Request Timeframe: Your refund request must be submitted via email to aval@mindovermarketmentorship.com within 7 calendar days of the final session (Day 3, July 1, 2026). Requests received after this window will not be honored under any circumstances.

Proof of Completion: You must provide evidence of completed exercises and participation when submitting your refund request. This may include completed worksheets, screenshots of Telegram participation, or other documentation we request.

If you meet **all** of the above conditions and do not feel you walked away with a clear, executable trading framework, email us and we will review your request and process your refund. Aval Trades reserves the right to verify attendance and participation records before approving any refund.

Non-Refundable Circumstances

Refunds will **not** be issued for:

- Failure to attend one or more of the 3 live sessions
- Change of mind or scheduling conflicts
- Requests submitted more than 7 days after Day 3
- Lack of results due to not following the system taught during the combine
- Personal or financial circumstances unrelated to the quality of the event

Due to the nature of live digital education and immediate access to proprietary materials, all sales outside of the guarantee conditions above are final.

Refund Process

If you meet the eligibility requirements above, send your refund request to the email address below. Include your full name, the email address used at purchase, and a brief explanation of your request. Refunds are processed within 5-10 business days of approval.

Chargebacks

We ask that you contact us directly before initiating a chargeback with your bank or payment provider. Initiating a chargeback without first attempting to resolve the issue with us may result in immediate termination of access to all combine materials, recordings, and resources.

We are committed to resolving any issues fairly and promptly.

Add-On Products

All add-on products purchased during or after checkout (including but not limited to the Combine Implementation Kit) are **non-refundable**. Due to the immediate delivery of digital materials and proprietary content, all add-on sales are final. The Show-Up-And-Do-The-Work Guarantee applies only to the core combine ticket (General Admission or VIP Access) and does not extend to any add-on products or supplementary materials.
