

TERMS OF SERVICE

By completing this purchase, you agree to the following terms.

These terms govern your relationship with OTHXRWHERE, operating as OTHXR ("OTHXR," "the Service," "we," "us"), accessible at othxr.xyz.

1. Nature of Service

This subscription provides access to an automated trading signal system ("the Service"). The Service posts trade alerts, market commentary, and educational content. The Service is not a financial advisory, is not a registered investment advisor, and does not manage funds or execute trades on your behalf. All content is provided for educational and informational purposes only.

2. Not Financial Advice

Nothing provided through the Service, including trade alerts, target prices, stop levels, backtested statistics, or published win/loss records, constitutes financial, investment, or trading advice. No content should be construed as a recommendation to buy, sell, or hold any security, futures contract, option, or digital asset.

3. Risk Acknowledgment

Trading futures, options, and cryptocurrency involves substantial risk of loss and is not suitable for all investors. You could lose some or all of your invested capital. Past performance, including any published or advertised track record, does not guarantee future results. By subscribing, you acknowledge that you understand and accept these risks in full.

4. Acknowledgment of Public Track Record

A record of the Service's historical alert performance is published publicly prior to purchase. By subscribing, you acknowledge that you had the opportunity to review this track record before purchasing, and that your purchase decision was made with that information available to you.

5. Your Responsibility

You are solely responsible for your own trading decisions, position sizing, risk management, and any financial outcome resulting from your use of the Service. The Service does not know your financial situation, risk tolerance, or investment objectives, and nothing provided is personalized to you.

6. Billing and Renewal

Subscriptions to OTHXR are billed on a recurring basis (monthly or as selected at checkout) until canceled. By subscribing, you authorize recurring charges to your payment method on each renewal date. You may cancel at any time through your account, cancellation takes effect at the end of the current billing period, and you will retain access until that period ends.

7. Refund Policy

Except where required by law, all sales are final once access to the Service has been granted for the current billing period.
